Terms of Reference for appointment of Consultant & Data Entry Operator1. Consultant**Work Responsibilities**

- Provide technical assistance to implement the project and ensure operational continuity of the project.
- Provide assistance for data collection, reporting, analysis and other local action pertaining to the project.
- Assist in co-ordination of various activities of the project by interacting with all the sectors involved in the project.
- Assist in development of trained health manpower by organizing training for core trainers and medical and paramedical professionals, monitoring training impact on the field and assessing emerging training needs.
- Provide assistance in implementation of id route of inoculation of cell culture anti-rabies vaccine
- Liaison with other departments that have relevance to the project (Animal Husbandry, Veterinary etc.)
- Assist in the organization of technical meetings
- Monthly reviews and compilation of periodic reports and plans under the project.
- Assist in co-ordinating the activities of the identified laboratories to be strengthened.
- Assist in maintenance of records and accounts.

Qualification and Experience: in order of preference either of the below:

Medical Graduate with Post Graduate Degree/Diploma (preferably in Epidemiology or Public Health such as MD, MPH, DPH, MAE, PhD etc. or Microbiology)

OR

Medical Graduate with 2 years experience in related field

OR

Post Graduate in field of Life Sciences, Social Sciences related to Public Health with 2 years experience in Field Epidemiology or experience in handling the health projects of similar nature

Age: 45 years or below (in exceptional cases age may be relaxed upto 60 years)

Monthly Remuneration: Consolidated Rs. 26,000/-

No other allowances are permissible except TA/DA on official tours as per Govt. rules.

Leave: 8 Casual Leaves, 2 Restricted Holidays, Government Gazetted Holidays as observed locally would be permissible.

The contract can be terminated by either side with one month notice.
