

Functions & Duties:- The Revenue Department in B.B.M.P is one of the very important Department. Since, much of the

Corporations Budgeting depends upon the taxes collected under the norms of K.M.C Act 1976. This Department works under the direct Supervision of Additional Commissioner (South)/Deputy Commissioner (Revenue). The main functions being Registration of Khathas/Clubbing of Khathas/Khatha Bifurcation and Khatha transfer and assessment of Properties to property taxes, in addition the department also deals with the issue of Khatha Extract/Certificate and Collection of rent from leased properties and also safe guarding the Corporation Properties.
