## **Eligibility Criteria for Two cover Tenders**

- 1. Any reputed Individual / Company registered with BBMP / CPWD / KPWD / Railways / MES or any State Government Organisations are eligible to apply.
- 2. No Joint Venture / Consortium is permissible.
- 3. The Tenderer shall have executed and completed successfully in the last five years i.e. between 2008 2009 and 2011 2012 a single work of similar nature of value not less than 80% estimated value of Contract. In support of this, the Tenderer shall furnish a Work Completion Certificate duly certified by the Competent Authority along with Technical Bid.
- 4. The Tenderer shall furnish the List of Man Power, Equipment and Machineries possessed by him / her.

- 5. The Tender is a two cover system consisting of
  - i. The Tenderer shall upload the following Documents in one cover inscribing the Cover as "Cover 1 Technical Documents (Technical Bid)".
- 1. Tenderer should submit their EMD and tender processing fee in the form of e-payment through e-Procurement Portal.

2. Bidders/Contractors can access tender documents on the website, fill them and submit the completed tender document into electronic tender on the website <a href="https://eproc.karnataka.gov.in/">https://eproc.karnataka.gov.in/</a>.

- a. Work Completion Certificate for having completed at least one work of similar nature of value not less than 80% estimated value of Contract, certified from the Competent Authority not below the Rank of Executive Engineer shall be enclosed. The Work Completion Certificate shall mention the Nature of Work, Items of Work executed and the Date of Commencement and Date of Completion of the Work.
- ii. The Tenderer shall upload the following Document in another cover inscribing the Cover as "Cover -2 (Financial Bid)".
  - a. Rates quoted in Bill of Quantities.
- 6. For those Tenderers whose Technical Bids do not satisfy the Eligibility Criteria as mentioned above, their Financial Bids will not be opened.

Aspiring Bidders/Contractors who have not registered in e-procurement should register before participating through the website <u>https://eproc.karnataka.gov.in</u>.

- 9. The successful Tenderer shall enter into the Agreement with the BBMP within 7 days of receipt of intimation. The Tender Document will form the part and parcel of the Agreement.
- 10. The Bruhat Bangalore Mahanagara Palike reserves the right to accept / reject any or all the Tenders without assigning any reasons.
- 11. The Tender will remain valid for **90** Days from the Date of Opening of Tender.
- 12. The Work shall be commenced with all Men and Machinery within **7 days** from the Date of Work Order, failing which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tenderer.

This difference amount will be returned after satisfactory completion of the work only. Failure to comply with the said conditions, the tender will be rejected
