The Bruhat Bangalore Mahanagara Palike (BBMP) invites proposals in Single cover system from interested persons/firms for maintenance of flyover against commercial advertisement(kiosks,glow sign boxes and advertising panels) BOT basis for a period of 3 years.

The tender can be downloaded in the portal as per prescribed date and time published in the portal. Only Interested Contractors who wish to participate should remit on line transaction fee **for tender after registering in the portal**. The transaction fee is non-refundable.

- Tenders must be accompanied by earnest money deposit of Rs.50,000 /= (Rs. Fifty housand only) for the package which should be paid online through e-Procurement portal using any of the following payment modes:
 - a. Credit Card
 - b. Direct Debit
 - c. National Electronic Fund Transfer (NEFT)
 - d. Over the Counter (OTC).
- **3.** Tender processing fee as per e-proc portal
- 4. Tenders must be electronically submitted (on-line through internet) with in the date and time published in e-procurement portal. Technical and financial bid's will be opened at prescribed time and date in the e-procurement portal, in the presence of the Tenderers who wish to attend at the Office Of The Executive Engineer (Advertisement) 2nd Floor, Annexe building, N.R. Square, Bangalore-560 002

5. Schedule of Bidding Process.

- 1. The application can be down loaded from 16.05.2013 onwards.
- 2. BBMP would endeavour to adhere to the following schedule:

a)	Last date and time for receipt of tenders	: 31.05.2013 upto 16: 00 Hours.
e)	Date and time for opening of Financial Bid	: 03.05.2013 at 17:00 Hours

6. Eligibility:

- 1. Any interested persons/firms can bid for the above work.
- 2. The tenderer should not be a defaulter to the BBMP.
- 3. The bidder should possess valid Enrollment certificate from BBMP for advertisement.
- 4. Terms used in this document which have not been defined herein, shall have the meaning ascribed thereto in the draft Agreement.
- 5. The Bidder should abide by the New Advertisement Bye-laws of B.B.M.P. whenever the same is brought into force.

7. Opening of the financial bids

This invitation of tenders is maintenance of flyover against commercial advertisement(kiosks,glow sign boxes and advertising panels) BOT basis. The financial bids of the highest bidding persons/firms will be considered.

8. Proposal preparation Cost

The Bidder shall be responsible and shall pay for all the costs associated with the preparation of proposal and its participation in the bidding process. BBMP will not be responsible or in any way liable for such costs, regardless of the conduct or outcome of the bidding process.

9. Inspection and Visit to the site.

- 1. Bidders may carry out the inspection of the sites at any time and at their own cost, as shown in Annexure 'A'.
- 2. It is desirable that each Bidder submits its proposal only after visiting the site and ascertaining for themselves the location, surroundings or any other matter considered relevant to his participation in the bidding process.
- 3. It would be deemed the Bidder has:
 - a) Made a complete and careful examination of terms & conditions/ requirements, and other information of the entire bidding process.
 - b) Received all such relevant information as requested from the BBMP and
 - c) Made, a complete and careful examination of the various aspects of the project including, but not limited to:
 - (i) Condition of the roads and utilities in the vicinity of the flyover.

- (ii) All other matters that might affect the Bidder's performance under the terms and conditions of this bid.
- 4. BBMP shall not be liable for any mistake or error on the part of the Bidder in respect of his participation in the process as per the Notification.
