2. The Tenders will be opened by the undersigned in the Office at if possible, otherwise next working day.
3. Tender documents may be downloaded from Government of Karnataka e-Procurement website <https://eproc.karnataka.gov.in/eportal/index.seam> under login of Contractors.
4. Tenders must be accompanied by earnest money deposit which will pay online through e-Procurement portal.
5. Tenders must be electronically submitted (on-line through internet) within the date and time published in e-procurement portal. First Cover Tenders will be opened at prescribed time and date in the e procurement portal, in the presence of the Tenderers who wish to attend at the **OFFICE OF THE EXECUTIVE ENGINEER-2 (Lakes), 3rd Floor, Annex Building-3, N.R .Square, Bangalore- 560002.**

- Last Date for uploading the Filled Tender Document is 11/03/2013 up to 4.00 p.m.
- Date of opening of Technical bid is 14/03/2013 at 4.30 p.m.
- The Financial bid of only those Tenderers who fulfill the eligibility criteria and qualification of Technical bid, will be, intimated and opened.

Eligibility criteria:

1. No Joint Ventures / Consortiums are permissible.
2. The firm shall have an Experience of having successfully completed similar nature of works in the last 5 years.
3. All consultants should submit the proof of works executed as above and “Satisfactory Performance Certificates” issued by an officer not below the rank of Executive Engineer / equivalent and in case of private firms from the Authorized signatory not below the rank of General Manager. In absence of such certification along with the tender, the tender is liable to be rejected. Preference will be given to such agencies, who have executed such or similar types of works for Government organizations.
4. The Tenderer shall have experience of similar nature of work in last Five years i.e. between 2007–2008 and 2011–2012 of project cost not less than Rs. 3.00 Lakhs. In support of this, the Tenderer shall furnish a Work Completion Certificate duly certified by the Competent Authority not less than the rank of Executive Engineer along with Technical Bid.
5. Achieved in at least two financial years out of last Five years i.e. between 2007-2008 and 2011-2012, a minimum turnover of not less than Rs. 4.00 Lakhs. In support of this, the Tenderer shall furnish a Certificate duly attested by a Chartered Accountant along with Technical Bid.
6. The Bidder should furnish the list of manpower, equipments and machineries possessed by him as per the tender documents.
7. Any litigation history of the firm/agency should be disclosed. Non-disclosure shall amount to cancellation of the tender.
8. Any false information furnished in the tender shall upon detection be liable for cancellation of the bid / agreement of the agency.
9. Conditional or incomplete tenders shall be rejected.
10. All correspondences between the consultants or BBMP should take place through acknowledgeable means in written form only. Oral or verbal communications are not liable to be acknowledged.
11. All the details/columns provided in the RFP document should be filled page wise and corrections if any shall be duly attested. Incomplete RFP documents are liable for rejection.
12. For those Tenderers whose Technical Bids do not satisfy the Eligibility Criteria as mentioned above, their Financial Bids will not be opened.
13. Financial and other details should be enclosed in the financial bid given.
14. The Bruhat Bangalore Mahanagara Palike reserves the right to accept / reject any or all the Tenders without assigning any reasons.

15. The successful Tenderer shall enter into the Agreement with the BBMP within 7 days of receipt of intimation. The Tender Document will form the part and parcel of the Agreement.
16. The Tender will remain valid for 180 Days after the Deadline Date for Tender Submission.
17. The Work shall be commenced with all Men and Machinery within 7 days from the Date of Work Order, failing which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tenderer.
