Tender documents may be downloaded from Government of Karnataka e-Procurement website <https://eproc.karnataka.gov.in> under login for Contractors: After login to Contractors, Please scroll down to the right side bottom to see List of Tenders, Please click there to find the details of NIT and download copy of the tender. The tender can be downloaded in the portal as per prescribed date and time published in the portal. Only Interested Contractors who wish to participate should remit on line transaction fee for tender after registering in the portal. The transaction fee is non-refundable if you wish to participate.
3. Tenders must be accompanied by earnest money deposit which should be paid online through e-Procurement portal using any of the following payment modes: Credit Card, Direct Debit, National Electronic Fund Transfer (NEFT), Over the Counter (OTC).Tenders must be electronically submitted (on-line through internet) within the date and time published in e-procurement portal. First Cover Tenders will be opened at prescribed time and date in the e procurement portal, in the presence of the Tenderers who wish to attend at the Office of the, Executive Engineer-2, Solid Waste Management-1, BBMP. 2<sup>nd</sup> Floor, Dasappa Hospital Premises, N,R Road,Bangalore-5600001,

### **Eligibility criteria:**

1. Any reputed Individual / Company registered with BBMP / CPWD / KPWD / Railways / MES or any State Government Organizations are eligible to apply.
2. No Joint Venture / Consortium is permissible.
3. The Tenderer shall have executed and completed successfully in any one financial year during block period of previous five financial years. i.e. between 2007 – 2008 and 2011-2012 a single work of similar nature of value not less than 80% value of amount put to tender In support of this, the Tenderer shall furnish a Work Completion Certificate duly certified by the Competent Authority not below the Rank of Executive Engineer shall be uploaded along with Technical Bid. The Work Completion Certificate shall mention the Nature of Work, Items of Work executed and the Date of Commencement and Date of Completion of the Work.
4. Tenderer shall furnish list of technical staff required for the work (Organization chart).and Equipment and Machineries possessed by him / her.
5. Present net worth not less than 75% of amount put to tender.
6. Should own at least 50% of the required key machineries /equipments for the work. Proof of ownership should be enclosed. Remaining 50% can be deployed on lease or hire basis, Proof for hire or lease agreement should be enclosed.
7. Achieved at least two financial years a minimum financial turnover not less than 2 times the estimated annual payment under this contract in all civil Engineering works in last 5 years.
8. The bidder must submit Line of Credit for an amount equal to estimated cash flow for 3 months i.e. 50% of the amount put to tender issued by Nationalized/Scheduled Bank in original, for the tendered work.
9. The bidder must submit balance sheets for proof of having annual turnover not less than twice the amount put to tender in any two of the previous five financial years, which shall be duly certified by a Chartered Accountant.
10. Latest income tax paid certificate (Challan) from the income tax department.
11. The intending tenderers shall furnish a cash flow chart on month to month basis for the entire period of execution of the work.
12. Provisional programme for completion of various items of work.
13. The bidder must submit Existing Commitments and On Going Works to be completed during the next 6 months.
14. The tender is of two cover system.
  - i) Bidders/Contractors Should attach all the Scanned copies of technical documents/ certificates pertaining to their eligibility criteria mentioned above in the website itself, failing which the bid will not be considered.(Technical Bid). The original documents should be produced for verification at any stage of tender process as and when sought for, failing which, the bids are liable for disqualification.
  - ii) Rates shall be quoted in Tender Schedule – B (Financial Bid) in the website itself.
15. For those contractors whose Technical bids do not satisfy the eligibility criteria, their financial Bids will not be opened.
16. The successful tenderer will have to execute agreement as present with BBMP within seven days of receipt of intimation.
17. The Bruhath Bangalore Mahanagara Palike reserves the right to accept / reject any or all the tenders without assigning any reasons.
18. The validity of tender is 6 months from the date of submission of tender.
19. The work should be commenced with all men and machinery within seven days from the date of work order, failing which it would be presumed that he is not interested in his work and action will be taken to get the work executed through alternate agency at the risk and cost of the former tenderer.
20. After opening of the tenders, before signing of the agreement, tenderer shall be asked to give a Demand Draft/Bank Guarantee for difference of amount between the quoted rates and the estimated cost, if the rates quoted are less than the estimated cost.
21. Conditional tenders will not be accepted.
