1. Tenders on item rate basis are invited by the undersigned for the work mentioned below from the registered contractors of Bruhat Bangalore Mahanagara Palike or equivalent registration with CPWD / KPWD / Railways / MES or any State Government Organizations. The Tenders will be opened by the undersigned in the Office at if possible, otherwise next working day.
2. Tender documents may be downloaded from Government of Karnataka e-Procurement website <https://eproc.karnataka.gov.in/eportal/index.seam> under login of Contractors.
3. Tenders must be accompanied by earnest money deposit which will pay online through e-Procurement portal.
4. Tenders must be electronically submitted (on-line through internet) within the date and time published in e-procurement portal. First Cover Tenders will be opened at prescribed time and date in the e procurement portal, in the presence of the Tenderers who wish to attend at the **Office of the Executive Engineer-5, Lakes, 3rd Floor, New Building, N.R. Square, Bangalore- 560002.**

- Last Date for receipt of Tenders is on **16/11/2013** up to 16.00 hours.
- Date of Opening of Technical bid is on **19/11/2013** by 16.30 hours or next working day.
- Financial Bid will be opened after the approval of Technical Evaluation from competent authority.

Eligibility criteria:

1. Any reputed Individual / Company registered with BBMP / CPWD / KPWD / Railways / MES or any State Government Organizations are eligible to apply.
2. No Joint Venture / Consortium are permissible.
3. The Tenderer shall have executed and completed successfully in any one financial year during block period of previous five financial years. i.e. between 2008 – 2009 to 2012 – 2013 a single work of similar nature of value not less than **80% value of amount put to tender**. In support of this, the Tenderer shall furnish a Work Completion Certificate duly certified by the Competent Authority not below the Rank of Executive Engineer shall be uploaded along with Technical Bid. The Work Completion Certificate shall mention the Nature of Work, Items of Work executed and the Date of Commencement and Date of Completion of the Work.
4. Tenderer shall furnish list of technical staff required for the work (**Organization chart**) and Equipment and Machineries possessed by him / her.
5. The bidder shall have Present **net worth not less than 75% of amount put to tender**.
6. The bidder should own at least **50% of the required key machineries /equipments** for the work. Proof of ownership should be enclosed. Remaining 50% can be deployed on lease or hire basis, Proof for hire or lease agreement should be enclosed.
7. The bidder shall have achieved at least two financial years a minimum financial turnover not less than **2 times the estimated annual payment** under this contract in all Civil Engineering works in last 5 years. The bidder must submit balance sheets for proof of having annual turnover as above, which shall be duly certified by a Chartered Accountant.
8. The bidder must submit **Line of Credit** for an amount equal to estimated cash flow for 3 months during peak construction period issued by Nationalized/Scheduled Bank in original, for the tendered work.
9. The bidder shall submit latest income tax paid certificate (Challan) from the income tax department.
10. The intending tenderers shall furnish a **cash flow chart** on month to month basis for the entire period of execution of the work.
11. The bidder must submit provisional program for completion of various items of work.
12. Tenderers who meet the above specified minimum qualifying criteria, will only be qualified, if their available tender capacity is more than the total tender value.
13. Tender Approval is subjected to the approval of the Detailed Project Report from the Lake Development Authority.
14. The tender is of two cover system.
15. Bidders/Contractors should attach all the scanned copies of technical documents/certificates pertaining to their eligibility criteria mentioned above in the website itself, failing which the bid will not be considered (Technical Bid) the original documents should be produced for verification at any stage of tender process as and when sought for failing which the bids are liable for disqualification.
16. Rates shall be quoted in **Tender Schedule – B** (Financial Bid) in the website itself.
17. For those contractors whose Technical bids do not satisfy the eligibility criteria, their financial Bids will not be opened.
18. The Bruhat Bangalore Mahanagara Palike Tender document is part and parcel of the agreement. The successful tenderer will have to execute agreement as present with BBMP within seven days of receipt of intimation.
19. The difference in Amount for unbalanced Tenders should be paid through Bank Guarantee/Banker's cheque / Demand draft/Pay Order in favor of COMMISSIONER, BBMP.

20. The Bruhat Bangalore Mahanagara Palike reserves the right to accept / reject any or all the tenders without assigning any reasons.
21. The validity of tender is 6 months from the date of submission of tender.
22. The work should be commenced with all men and machinery within seven days from the date of work order, failing which it would be presumed that he is not interested in his work and action will be taken to get the work executed through alternate agency at the risk and cost of the former tenderer.
23. After opening of the tenders, before signing of the agreement, tenderer shall be asked to give a Demand Draft in favor of Commissioner, BBMP for difference of amount between the quoted rates and the estimated cost, if the rates quoted are less than the estimated cost.
24. Conditional tenders will not be accepted.
