- 1. The Executive Engineer, (Bangalore South Division), BBMP Bangalore-62. Invites tenders from eligible Contractors registered in Bruhat Bangalore Mahanagara Palike, or equivalent Registration with / KPWD/CPWD/ Railways/MES/National Highway or any state Government Organizations for the Construction of works detailed in the table below. The tenderers may submit tenders for works given in the table through e-procurement portal of the Government of Karnataka (viz http://eproc.karnataka.gov.in). The Tenderers are advised to note the minimum qualification criteria specified in clause 3 of the instructions to Tenderers to qualify for award of the contract (Standard Tender Document KW2)
- 2. Tender documents may be downloaded from the e-procurement portal of the Government of Karnataka from **01.04.2013**
- 3. Tenders must be accompanied by Earnest Money Deposit specified for the work in the table below. Earnest money deposit will have to be in any one of the forms as specified in the Tender document and shall have to be valid for 90 days beyond the validity of the Tender.
- 4. Tenders must be submitted online through e-procurement portal on or before 16.00 hours on <u>08.04.2013</u> and the opening of tenders will be as per the e-procurement portal guidelines.

TERMS & CONDITIONS:

- 1. Any reputed Individual / Company registered with BBMP / CPWD / KPWD / Railways / MES or any State Government Organizations are eligible to apply.
- 2. No Joint Venture / Consortium is permissible.
- 3. The Tender Should be accompanied by the Registration certificate.
- 4. The Competent authority of the Bruhat Bangalore Mahanagara Palike reserves the right to accept or reject any or all the tenders without assigning any reason thereon.

- 5. The Income Tax and V.A.T. as applicable will be deducted from every running and final bill of the contractor.
- 6. The Tender will remain valid for 180 Days after the Deadline Date for Tender Submission.
- 7. The Work shall be commenced with all Men and Machinery within 7 days from the Date of Work Order, failing which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tenderer.
- 8. Tenderer who have the works pending with them will not be entertained.
- 9. The work shall be carried out as per the directions of the BBMP Engineer in-charge
- 10. Tender capacity of the Contractor will be based on qualification information vide clause of the Instructions to the Contractors.
- 11. The defect liability period for completed works is as shown in from the date of final bill.
- 12. (a) The E.M.D and S.D will be refunded only after Completion of the defect liability period.
 - (b) The Total E.M.D and F.S.D amount should be 7.5% of the project cost as applicable.
 - (c) In Asphalting works the Contractor shall complete the work to the satisfaction of the corporation and shall rectify the defects developed within the guarantee period as per Commissioner inter Office Note No: Comm./PR/1043/2009-10 Dt: 26-10-2009 the EMD and SD recovered from the contractor's bills shall be released only after the guarantee period as per Commissioner Inter Office Note of Dt: 26-10-2009 without any interest thereon As follows.
 - (1). Asphalting (Strengthening of road Provision of DBM/BM/BC/& BM/SDBC in Asphalting) Maintenance period Minimum 5 years
 - (2). Asphalting (Works Provisions of BM for Camber/SDBC & SDBC/ OGPS/ or CGPS) Maintenance period Minimum 3 years
- 13. If the amount quoted by the Contractor is below the estimated amount put to tender the contractor should deposit the difference amount between quoted amount and the amount put to tender in the form of D.D at the time of executing agreement.
- 14. Further particulars can be obtained from the office of the Executive Engineer, Bangalore South Division, Amruth Nagara, Konanakunte Main road, Soudhamini Layout, Bruhat Bangalore Mahanagara Palike, Bangalore-62, during the working days between 10.00 A.M to 5.30 P.M
- 15. The prevailing S.R. Rates of Bitumen / Cement / Steel at the time of opening of tenders consider as per Para(4) of general notes to the S.R of Bangalore circle for the year 2012-13.
- 16. 1% of the cost of the bill will be deducted under the building and other construction workers welfare cess act 1996 as per G.O. No.LD/300/LET/2006, Dated: 18.1.2007 and as per Bruhat Bangalore Mahanagara Palike Chief Accounts Officers Circular Vide No.BBMP/CAO/PR/6/07-08, Dated: 3.8.2007.
- 17. Road cut Portin: During the maintenance period if any other agency cut the road for laying BWSSB/OFC/BESCOM & other agency the contractor has to re do the road cut portion. If necessary permission / payment will be made to the contractor by the other agency through Bruhat Bangalore Mahanagara Palike.
- 18. All the participants should produce all the original documents for verification whenever necessary.

Eligibility Criteria Follows

i) The Bidder should have executed and completed successfully within the stipulated contract period a single work of similar nature contract not less than 60% of tender amount in financial Years of 2011-12. In support of this, bidder should furnish a certificate duly certified

- by the competent authority along with Technical bid. Achieved in at least two financial years a minimum turnover not less than two times the amount put to tender.
- ii) Present net worth should be two times the amount put to tender. In support of this, bidder should furnish certificate certified by the Charted Accountant.
- iii) The bidder should have his own plant and machinery and furnish the list of man power, equipments and machineries possessed by him as per the tender document.
- iv) The bidder should quote for all items In all sub works

The Tender is a two cover system consisting of

TECHNICAL BID

The Technical bid should contain EMD, details of technical, financial & managerial capabilities to execute the work as per the requirements in Para (i) to (iv) above.

FINANCIAL BID

The Financial bid contain only price bid. For such of those contractors, whose technical bids do not satisfy the eligibility, their financial bids will not be opened and the tenders will summarily rejected.
