- 1. Conditional tenders will not be accepted.
- 2. The contractor has to make own arrangements for procurements of all materials.

There is no departmental supply of materials. Contractor should procure materials with BIS and other relevant standards & obtain necessary quality control certificates from authorized quality control authority.

- 3. Sub-letting of work is prohibited.
- 4. Corrigendum/Modification Corrosions if any will be notified in the Notice Board of the undersigned and in the website www.tenderwizard.com/BBMP
- 5. As per the Government Order No. LD 300/LET/2006, Dated: 18.7.2007 1% of the bill amount will be deducted and remitted to Karnataka State Building & other contraction Employees Welfare Board.
- 6. Necessary taxes and other deductions will be made from contractor bills.
- 7. The successful bidder will have to execute an agreement with BBMP within 7 days of receipt of intimation, failing which his tender is liable to be rejected.
- The Bruhat Bangalore Mahanagara Palike reserves the right to accept/reject any or the entire tender's without assigning any reasons.
- 9. The Contractors interested in Bidding for the work mentioned above may submit an application to the undersigned along with cost of Tender Documents as per column 7 of the above table to be paid in the form of Demand Draft or Pay Order drawn in favour of the commissioner BBMP A/c of the Executive Engineer BTM Layout Division. Bangalore of any Nationalised Bank and obtain approval for registration with authorized e-tendering agency M/s KEONICS, No. 24, First Floor, Sudha Complex, 3rd stage, 4th block, Basaveshwaranagar, Bangalore- 560 079.
- 10. The Tender should have to produce contractors registration book issued by the concerned authority for procurement of tender documents. Applicant should submit proof of registration, latest income Tax Clearance Certificate, obtained from the Concerned Department while submitting the request for application for the Tender Schedules; otherwise the application will be rejected.
- 11. The requisite EMD as mentioned in column **6** of the above table in the form of DD/Pay Order drawn in favour of the Commissioner BBMP A/c of the Executive Engineer (BTM) Layout Division BBMP Bangalore. The Original DD/pay order should be submitted before opening the e-tender. If the bidder fails to submit the Original DD/Pay Order before the prescribed time their Tender will be disqualified. Regarding the Validity of Bid Security (EMD), Tender Conditions etc., Standard Tender Document shall be referred and his binding on the Tenderer.
- 12. The work should be commenced with all earnestness within 7 days from the date of work order, failing which it would be presumed that he is not interested in the work and action will be taken to get the work executed through alternate agency at the risk and cost of the former Tender.
- 13. Any other details regarding the above mentioned works & other information may be obtained from the above office during office hours.
- 14. Latest Income Tax clearance certificate from the Income Tax Department. To be submitted.
- 15. If the rate/amount quoted by the tenderer is less than the rate/amount of the Tender amount, such tenderer while submitting the tender shall remitt the difference amount it form of DD in favour of The Commissioner BBMP A/c of the Executive Engineer (BTM) Layout Division Bruhat Bangalore Mahanagara Palike along with separate EMD amount. This difference amount will be returned after satisfactory completion of the work only. Failure to comply with the said conditions, the tender will be rejected.

- 16. The tenders shall be strictly as per the formats and terms and conditions specified in the tender documents. Lump sum tenders will not be considered. Separate tenders shall be submitted for each work.
- 17. The tenders will be opened on the due date and time of opening indicated in the tender documents the blank tender form will be accessible in website and Tenders must be submitted to BBMP at the website www.tenderwizard.com/BBMP up to 4.00pm. It the event of the specified date for the submission of EMD for the tenders being declared a holiday for the BBMP, the tenders will be received up to the appointed time on the next working day.
 - BBMP at its discretion may review the various terms and conditions of tender and extend the deadline for submission of tenders by issuing an amendment, in which case all rights and obligations of the BBMP and the Tenders previously subject to the original deadline will then be subject to the new deadline.
- 18. Quantities of work: The tenderer has to submit the tender as per quantities indicated in the schedule 'B' only. However, the tenderer has to make his pre-bid survey for complete reverification of quantities and site condition before submitting the tender.
- 19. The Bruhath Bengalore Mahanagara Palike Tender Document (KW-1) is part and parcel of the agreement. This deed has to be signed with BBMP within seven days of intimation.
