Aspiring Bidders/Contractors who have not registered in e-procurement should register before participating through the website <https://eproc.karnataka.gov.in>.

3. Any reputed Individual / Company registered with BBMP / CPWD / KPWD / Railways / MES or any State Government Organizations are eligible to apply.
4. No Joint Venture / Consortium is permissible.
5. Certified copy of the valid Registration Certificate issued by the for the block period of 2010-2015 should be enclosed with the tender documents.
6. The Standard Tender Document – **KW1 & KW2** and other Tender Document will form the part and parcel of the Agreement. and the Tenderers are advised to note the minimum qualification criteria specified in Clause 3 of the Instructions to Tenderers to qualify for award of the contract.
7. Earnest money deposit will have to be in any one of the forms as specified in the Tender document and shall have to be valid for 45 days beyond the validity of the tender.
8. As per Special. Commissioner (project) Circular No.ION/PR/(1)/08/07-08, Dt:16/10/07, and Engineer-In-Chief Order No: EIC/EC/PR/606/07-08, dated: 24/9/2007. The following conditions are stipulated in the tender, “The amount quoted by the tenderer is less than the tender amount, such tenderer shall remit the difference amount before signing the Agreement, in the form of DD in favour of Commissioner, B.B.M.P. along with separate E.M.D. amount. This difference amount will be returned after, satisfactory completion of the work only and failure to comply the said conditions, the tender will be rejected
9. The contractor should furnish the statement of ongoing work as well as stipulated period of completion remaining for each of works listed should be counter signed by the employer incharge not below the rank of Executive Engineer as per SBD Qualification information 1.3 A & B.
10. The contractor should furnish the details of maximum value of civil Engineering works executed is any one year during the last five years.
11. The tenderer shall furnish the list of man power, equipment and machineries possessed / leased by him as noted is the tender documents.
12. The Bruhat Bangalore Mahanagara Palike reserves the right to accept / reject any or all the Tenders without assigning any reasons.
13. The Tender will remain valid for 90 Days after the Deadline Date for Tender Submission.
14. The Work shall be commenced with all Men and Machinery within 3 days from the Date of Work Order, failing which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tenderer.
15. Tenderer who have the works Pending with them will not be entertained.
16. The EMD and FSD amount will be returned after successful completion of ONE year.
17. Certified Xerox copies of the documents shall be enclosed along with the Tender, failing which the tender will be rejected.
18. The Income Tax at the rate of 1.30%, KST at 4% and Cess at 1% will be Deducted and certificate will be issued in favour of the Contractor from every running bill / final bills of the contractor:
19. The rates quoted in the schedule shall be inclusive of all taxes applicable.
20. The work shall be carried out as per the directions of the BBMP and Engineer in-charge

21. Black Listed Contractors / in Govt. / Quasi Govt. / Boards / BBMP etc., are not eligible to quote, if found such Tenders will be rejected.
22. The successful Tenderer shall execute an Agreement within 7 days from the date of receipt of the intimation from this Office, failing which the Tender will deem to be get cancelled.
23. The materials shall be got approved by the undersigned before Execute the work.
24. All the participants should produce all the original documents for verification whenever necessary.
25. Conditional tenders will not be accepted.
