The Executive Engineer (Chamarajpet), BBMP, Bangalore invites tenders from eligible Contractors registered in Bruhat Bangalore Mahanagara Palike or equivalent registration with CPWD / KPWD / Railways / MES/National Highway or any State Government Organizations for the construction of works detailed in the table below. The tenderers may submit tenders for works given in the table through e-procurement portal of the Government of Karnataka (viz <http://eproc.karnataka.gov.in>).

Tenders must be accompanied by Earnest Money Deposit specified for the work in the table below. Earnest money deposit will have to be in any one of the forms as specified in the Tender document and shall have to be valid for 45 days beyond the validity of the tender.

Tenders must be submitted online through e-procurement portal on or before 16.00 hours **24-10-2013** and the opening of tenders will be as per the e-procurement portal guidelines.

## **ESSENTIAL CONDITIONS:**

1. Those who are quoting below percentage should remit the difference Amount alongwith the EMD amount at the time of quoting of Tender only as per the direction of Chairman, Ward level Committee for works, BBMP, and meeting proceedings dated:24-05-2011 presided by Worshipful Mayor.
2. **The L1 Contractor should Remitt the Demand Draft 5% F S D amount based on estimated cost of Work at the time of Agreement.**
3. The eligible contractors those who are registered in other Organisations should be registered in BBMP before issuing the work Order.
4. No Joint Venture / Consortium is permissible.
5. Conditional tender will not be accepted.
6. The Contractor has to make own arrangements for procurement of all materials required for the work. There is no departmental supply of materials. Contractor should procure materials with BIS or Other relevant standards & obtain necessary quality control certificates from authorized quality control authority.
7. The Contractor is not eligible for submission of application for tender form if he has not put the tender after purchase of the tender document continuously for three times.
8. Sub-Letting of work is prohibited.
9. The work shall be commenced with all Men, Machinery within 7 days from the Date of work Order, failing which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk & cost of the Former Tenderer.
10. Any Corrigendum/Modification will be notified in the Notice Board of the undersigned.
11. As per Government order no.LD 300/LET/2006, dt,18/01/2007, 1% of the Estimate Cost will be deducted and remitted to Karnataka State Building & Other Construction Employees Welfare Board.
12. Necessary Taxes and other deductions will be made from contractors Bills
13. The maintenance of period in case of Chipcarpetting and Asphaltting works is 2 years and 1 year for civil works from the date of final bill/or after the expiry of maintenance period whichever is later.
14. For Asphaltting works, like Pothole filling, chip carpetting, BM & BC etc., those who own their hot mix plant and mechanical pavers only need apply, Such of those tenderer will have to furnish the list of machinery equipment along with the copy of the Registration certificate at the time of scanning of tender documents.
15. Frequency of the quality tests of all the materials and other tests have to be conducted by contractor as per MORT & H (iv Revision)IRC guidelines and other relevant Indian standards in his laboratory or any other Laboratory assigned by the BBMP on his own cost in presence of Engineer/consultants appointed by BBMP.
