#### **ESSENTIAL CONDITIONS:**

- The Bid Security (EMD) is in the form of DD/FDR/Pay Order/Bank Guarantee drawn in favour of the Executive Engineer, Chamarajpet Division, BBMP, Bangalore payale at Bangalore from nationalized/scheduled bank and after scanning the same for download of Bill of Quantities, the Original DD should be submitted before opening the electronic tender box. If the Bidder fails to submit the Original DD before opening the e-tender box, his tender will be the disqualified. Regarding the validity of bid security (EMD), Tender condition etc., PWG-66 and SBD shall be referred and is binding on the tenderer.
- 2. No. Joint Venture / Consortium is permissible.
- 3. Conditional tender will not be accepted.
- 4. The Contractor has to make own arrangements for procurement of all materials required for the work. There is no departmental supply of materials. Contractor should procure materials with BIS or Other relevant standards & obtain necessary quality control certificates from authorized quality control authority.
- 5. The Contractor is not eligible for submission of aplication for tender form if he has not put the tender after purchase of the tender document continuously for three times.
- 6. Sub-Letting of work is prohibited.
- 7. The successful Tender shall pay the Difference Cost if any within 7 days from the date of receipt of the intimation from this Office, filing which the a Tender will get cancelled without any further notices.
- 8. The work shall be commenced with all Men Machinery within 7 days from the Date of work Order, filing which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk & cost of the Former Tender.
- 9. Any Corrigendum/Modification will be notification in the Notice Board of the undersigned.
- 10. As per Government orser no.LD 300/LET/2006, dt,18/01/2007, 1% of the Estimate Cost will be deducted and remitted to Karnataka State Building & Other Construction Employees Welfare Board.
- 11. Necessary Taxes and other deductions will be made form contractors Bills
- 12. If the rates quoted are less than the estimated cost, after opening of the tenders, before signing of the agreement tenderer shall be asked to give a demand draft for the difference of amount between the quoted rates and the estimated costs at the time of Agreement
- 13. The maintenance of period in case of Chipcarpetting and Asphalting works is 2 years and 1 year for civil works from the date of final bill/or after the expiry of maintenance period whichever is later.
- 14. For Asphalting works, like Pothole filling, chip carpetting, BM & BC etc., those who own their hot mix plant and mechanical pavers only need apply, Such of those tenderer will have to furnish the list of machinery equipment along with the copy of the Registration certificate at the time of scanning of tender documents.
- 15. Frequency of the quality tests of all the materials and other tests have to be conducted by coantractor as per MORT & H (iv Revision)IRC guidelines and other relevant Indian standards in his laboratory or any other Laboratory assigned by the BBMP on his own cost in presence of Engineer/consultants appointed by BBMP.
