1. Percentage Tenders for the works noted in the Table below, are invited through e-tendering, by the Executive Engineer Electrical, BBMP West Division on behalf of Commissioner, Bruhat Bengaluru Mahanagara palike as per Karnataka Transparency in Public Procurement Act 1999 & Rules 2000 from Electrical Contractors, registered in KPWD/BBMP. The electronic tenders will be opened by the undersigned on the dates mentioned under time schedule. If any one of the dates noted happens to be a general holiday, the next working day holds good. The brief features of work, pre-qualification requirements and conditions of tender and contract are described below. However, for full details, the various sections of the tender document need to be referred to. Tenderers having suitable technical, financial and managerial capabilities only need to submit the tenders. Cost of the Tender form is indicated in the table given below. Tender forms will not be sent by post; Tenders are not transferable.
2. Aspiring bidders / contractors who have not obtained the user ID and Password for participating in the e-tendering in BBMP, may obtain the same from web site www.tenderwizard.com/BBMP through link 'Register me' .

TERMS AND CONDITIONS

1. No Joint Venture/Consortium is permissible.
2. Conditional Tenders will not be accepted.
3. The Contractor has to make own arrangements for procurement of all materials required for the work. There is no departmental supply of materials. Contractor should procure materials with BIS or other relevant standards & obtain necessary quality control certificates from authorized quality control authority.
4. The Contractor is not eligible for submission of application for tender form if he has not put the tender after purchase of the tender document continuously for three times.
5. Sub-letting of work is prohibited.
6. Certified Xerox copy of the valid Registration Certificate issued by the Bruhat Bangalore Mahanagara Palike for the block period of 2010-2015 should be enclosed with the tender documents and the valid electrical inspectorate license
7. Any Corrigendum/Modification will be notified in the Notice Board of the undersigned.
8. Necessary Taxes and other deductions will be deducted from contractors Bills as per the government orders.
9. The Bruhat Bengaluru Mahanagara Palike reserves the right to accept/reject any or the entire tender's without assigning any reasons.
10. In view of implementation of e-payment facility for e-tendering activity in BBMP, The Contractors interested in Bidding for the work mentioned above may log on to BBMP e-tender portal to initiate the transaction i.e., download the application forms, The contractor has to make the payment for tender application fee and for EMD for the concerned tender. The contractor then proceeds towards the payment options. The payment may be made over the internet using the Credit Card/Debit Card or through RTGS challan system by downloading from the e-Tender Portal. 11. The Successful Bidder will have to execute and agreement with the undersigned within 7 days of receipt of intimation, failing which his tender will be rejected.
12. The Work should be commenced with all earnestness with in 7 days from the date of Work Order, failing which it would be presumed that he is not interested in the work and action will be taken to get the work executed through alternate agency at the risk and cost of the former Tender.
13. The work shall be carried out as per the directions of the BBMP and BESCO Engineer in-charge.
14. Aspiring Bidders/Contractors who have not obtained the user ID and Password for participating in the e-Tendering in BBMP/may obtain the same from the web-site www.tenderwizard.com/bbmp through link 'Register me'.
15. Any other details regarding the above mentioned works & other information may be obtained from the above Office during Office hours..
16. If the rate/amount quoted by the tenderer is less than the rate/amount of the Tender amount, such tenderer, while executing the Agreement shall remit the difference amount in form of DD/Payorder in favour of Executive Engineer, (Electrical), West, Bruhat Bangalore Mahanagara Palike. This difference amount will be returned after satisfactory completion of the work only. Failure to comply with the said conditions, the tender will be rejected.

17. The tenders shall be strictly as per the formats and terms and conditions specified in the tender documents. Lump sum tenders will not be considered. Separate tenders shall be submitted for each work.
18. Contractors should quote the rates in Indian Rupee & should be inclusive of all taxes & levies.
19. Tenderers can submit the tenders for all the works, However this is subject to fulfillment of tender capacity condition as per standard tender document for procurement of **works KW-1**.
20. Black Listed Electrical Contractors / in Govt. / Quasi Govt. / Boards / BBMP etc., are not eligible to quote, if found such Tenders will be rejected.
21. The tenders will be opened on the due date and time of opening indicated in the tender document.
22. Deadline for submission of tender:
23. BBMP at its discretion may review the various terms and conditions of tender and extend the deadline for submission of tenders by issuing an amendment, in which case all rights and obligations of the BBMP and the Tenderers previously subject to the original deadline will then be subject to the new deadline. Tenders will not be accepted after the time fixed for receipt of bids.
24. Quantities of work: The tenderer has to submit the tender as per quantities indicated Schedule 'B' only. However, the tenderer has to make his pre-bid survey for complete re-verification of quantities and site condition before submitting the tender.
