Only Interested Contractors who wish to participate should remit on line transaction fee for tender after registering in the portal. The transaction fee is non-refundable if you wish to participate.

Tenders must be accompanied by earnest money deposit which should be paid online through e-Procurement portal using any of the following payment modes: Credit Card , Direct Debit, National Electronic Fund Transfer (NEFT), Over the Counter (OTC).

Tenders must be electronically submitted (on-line through internet) with in the date and time published in e-procurement portal. - 1. Any reputed Individual / Company registered with BBMP / CPWD / KPWD / Railways / MES or any State Government Organizations are eligible to apply.
- 2. For the work at Sl.no 01 the agency should have dealership certificate from companies who deals with similar nature of work.
- 3. Certified Xerox copy of the valid Registration Certificate issued by the Bruhat Bangalore Mahanagara Palike for the block period of 2010-2015 should be enclosed with the tender documents and the valid electrical inspectorate license
- 4. The Tender Document will form the part and parcel of the Agreement.
- 5. As per Special. Commissioner (project) Circular No.ION/PR/(1)/08/07-08, Dt:16/10/07, and Engineer-In-Chief Order No: EIC/EC/PR/606/07-08, dated: 24/9/2007. The following conditions are stipulated in the tender, "The amount quoted by the tenderer is less than the tender amount, such tenderer shall remit the difference amount before signing the Agreement, in the form of DD in favour of Executive Engineer (Ele), West Division, B.B.M.P. along with separate E.M.D. amount. This difference amount will be returned after, satisfactory completion of the work only and failure to comply the said conditions, the tender will be rejected
- 6. The Bruhat Bangalore Mahanagara Palike reserves the right to accept / reject any or all the Tenders without assigning any reasons.
- 7. The Tender will remain valid for 90 Days after the Deadline Date for Tender Submission.
- 8. The Work shall be commenced with all Men and Machinery within 7 days from the Date of Work Order, failing which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tenderer.
- 9. Tenderer who have the works Pending with them will not be entertained.
- 10. The EMD and SD amount will be returned after successful completion of ONE year.
- 11. The Tender Accepting Authority shall have the power to accept to reject any tender without assigning any reason thereof.
- 12. The Tenderer shall give one year Guarantee for the instruments and maintain for one year and replace such parts, fused out, burnt out and defective parts thereon at free of cost.

- 13. Certified Xerox copies of the documents shall be enclosed along with the Tender, failing which the tender will be rejected.
- 14. The Income Tax at the rate of 2.30%, KST at 4% and Cess at 1% will be Deducted and certificate will be issued in favour of the Contractor from every running bill / final bills of the contractor:
- 15. The rates quoted in the schedule shall be inclusive of all taxes applicable.
- 16. The work shall be carried out as per the directions of the BBMP Engineer in-charge of work.
- 17. Black Listed Electrical Contractors / in Govt. / Quasi Govt. / Boards / BBMP etc., are not eligible to quote, if found such Tenders will be rejected.
- 18. The successful Tenderer shall pay the Difference Cost if any within 7 days from the date of receipt of the intimation from this Office, failing which the Tender will get cancelled without any further notices.
- 19. The successful Tenderer shall execute an Agreement within 7 days from the date of receipt of the intimation from this Office, failing which the Tender will deem to be get cancelled.
- 20. The sample & make shall be got approved by the undersigned before Executing the work.
