Eligibility Criteria:

1. Any reputed Individual / Company registered with BBMP / CPWD / KPWD / Railways / MES or any State Government Organizations are eligible to apply.
2. No Joint Venture / Consortium is permissible.
3. The Tenderer shall have executed and completed successfully in the last five years i.e., between 2007-08 to 2011-12 a single work of similar nature of value not less than the estimated value of contract. In support of this, the Tenderer shall furnish a work completion certificate duly certified by the Competent Authority along with Technical Bid.
4. The Tenderer shall have achieved in at least two financial years a minimum of turn over not less than the Two times the amount put to tender.
5. Work completion certificate for having completed at least one work of similar nature of value not less than the estimated value of contract certified from the competent authority not below the Rank of Executive Engineer shall be uploaded. The work completion certificate shall mention the nature of work, items of work executed and the date of commencement and date of completion of the work.
6. The tenderers shall upload the valid and present certificate copies of PAN, VAT No., service Tax Registration No, Contractor'S Registration pass book for technical bid qualification eligibility.
7. As per Special Commissioner (project) circular no ION/PR(1)/08/07-08 Dt: 16/10/07, and Engineer-in-chief order no:EIC/EC/PR/606/07-08 Dated: 24/9/2007. The following conditions are stipulated in the tender " The amount quoted by the tenderer

is less than the tender amount, such tenderer shall remit the difference amount before signing the Agreement, in the form of DD favour of Commissioner, BBMP along with separate EMD amount. This difference amount will be returned after, satisfactory completion of work only and failure to comply the said conditions, the tender will be rejected.

8. The work shall be carried out as per the directions of the BBMP and Engineer-in-charge.
9. Black listed contractors/in govt/Quasi govt/Boards/BBMP etc., are not eligible to quote, if found such tenders will be rejected
10. The successful tenderer shall pay the Difference Cost of any within 7 days from the date of receipt of the intimation from this office, failing which the tender will get cancelled without any further notices.
11. The successful Tenderers shall execute an Agreement within 7 days from the date of Receipt of intimation from this office, The Tender Document will form the part and parcel of the agreement, failing which the tender will be deemed to be cancelled.
12. The material shall be got approved by the undersigned before execute the work.
13. Further details of the work can be obtained from the office of the Executive Engineer, Hebbal Division, Thimmaiah Road, Queen's Road, Bangalore-52 on all working days during office hours.
14. All the participants should produce all the original documents for verification whenever necessary.
15. Certified Xerox copies of the documents shall be enclosed along with the tender, failing which the tender will be rejected.
16. The Taxes and Cesses will be deducted as per the governing norms and certificate will be issued in favour of the Contractor from every running bill / final bills of the contractor.
17. The rates quoted in the schedule shall be inclusive of all taxes applicable.
18. The Bruhat Bangalore Mahanagara Palike reserves the right to accept / reject any or all the tenders without assigning any reasons.
19. The tender will remain valid for 90 days after the deadline date for tender submission.
20. The work shall be commenced with all men and machinery within 7 days from the date of work order, failing which it would be presumed that the successful tenderer is not interested in the work and action will be taken to get the work executed through alternate agency at the risk and cost of the former tenderer.
