The tenderers may submit tenders for works given in the table through E - Tendering (viz www.tenderwizard.com/bbmp).

Last date for Receipt of Application for Tender Document **14-03-2013** up to **4.00 PM** and As per Circular No CFO 31 / Training / 2010 dt: 03-09-2012 the intending contractors may download the application forms by log on to BBMP E-Tender Portal. The Payment for tender forms may made over through the internet using the Credit Card / Debit Card or through RTGS Challan system by downloading from E-Tender Portal.
