TERMS AND CONDITIONS OF TENDER NOTIFICATION

1. No Joint Venture/Consortium is permissible.
2. Conditional Tenders will not be accepted.
3. The Contractor has to make own arrangements for procurement of all materials required for the work. There is no departmental supply of materials. Contractor should procure materials with BIS or other relevant standards & obtain necessary quality control certificates from authorized quality control authority.
4. The Contractor is not eligible for submission of application for tender form if he has not put the tender after purchase of the tender document continuously for three times.
5. Sub-letting of work is prohibited.
6. Any Corrigendum/Modification will be notified in the Notice Board of the undersigned.
7. Necessary Taxes and other deductions will be deducted from contractors Bills as per the government orders.
8. The Bruhat Bangaluru Mahanagara Palike reserves the right to accept/reject any or the entire tender's without assigning any reasons.

9. In view of implementation of e-payment facility for e-tendering activity in BBMP, The Contractors interested in Bidding for the work mentioned above may log on to BBMP e-tender portal to initiate the transaction i.e., download the application forms, The contractor has to make the payment for tender application fee and for EMD for the concerned tender. The contractor then proceeds towards the payment options. The payment may be made over the internet using the Credit Card/Debit Card or through RTGS challan system by downloading from the e-Tender Portal. 10. The Successful Bidder will have to execute and agreement with the undersigned within 7 days of receipt of intimation, failing which his tender will be rejected.
11. The Work should be commenced with all earnestness with in 7 days from the date of Work Order, failing which it would be presumed that he is not interested in the work and action will be taken to get the work executed through alternate agency at the risk and cost of the former Tender.
12. If any bidder is quoting the rates below the tendered amount, the bidder should scan the difference in amount DD & upload the same while submitting the tender. & the bidder has to come along with the difference in amount DD during the opening of the tender. Otherwise the bid will be rejected.
13. The Blank Tender Form will be accessible on web-site (www.tenderwizard.com/BBMP).
14. Aspiring Bidders/Contractors who have not obtained the user ID and Password for participating in the e-Tendering in BBMP/may obtain the same from the web-site www.tenderwizard.com/bbmp through link 'Register me'.
15. Any other details regarding the above mentioned works & other information may be obtained from the above Office during Office hours.
16. If the rate/amount quoted by the tenderer is less than the rate/amount of the Tender amount, such tenderer, while submitting the tender shall remit the difference amount in form of DD in favour of **Commissioner, Bruhat Bangalore Mahanagara Palike**, along with separate EMD amount". This difference amount will be returned after satisfactory completion of the work only. Failure to comply with the said conditions, the tender will be rejected.
17. **Deadline for submission of tender**

Tenders must be submitted to BBMP at the website www.tenderwizard.com/BBMP address specified before- 23-11-2013 upto 4.00 pm. In the event of the specified date for the submission of tenders being declared a holiday for the BBMP, the tenders will, be received up to the appointed time on the next working day.

BBMP at its discretion may review the various terms and conditions of tender and extend the deadline for submission of tenders by issuing an amendment, in which case all rights and obligations of the BBMP and the Tenderers previously subject to the original deadline will then be subject to the new deadline. Tenders will not be accepted after the time fixed for receipt of bids.
18. **Quantities of work: The tenderer has to submit the tender as per quantities indicated Schedule 'B' only.** However, the tenderer has to make his pre-bid survey for complete re-verification of quantities and site condition before submitting the tender.
