1. No Joint Venture/Consortium is permissible.
2. Conditional Tenders will not be accepted.
3. The Contractor has to make own arrangements for procurement of all materials required for the work. There is no departmental supply of materials. Contractor should procure materials with BIS or other relevant standards & obtain necessary quality control certificates from authorized quality control authority.
4. The Contractor is not eligible for submission of application for tender form if he has not put the tender after purchase of the tender document continuously for three times.
5. Sub-letting of work is prohibited.
6. Any Corrigendum/Modification will be notified in the Notice Board of the undersigned.
7. As per Government order No. LD 300/LET/2006, Dt: 18-07-2007 1% of the bill amount will be deducted and remitted to Karnataka State Building & Other Construction Employees Welfare Board.
8. The successful bidder will have to execute an agreement with BBMP within 3 days from the date of issue of Letter of Acceptance failing which his tender is liable to be rejected.
9. The work should be commenced with all earnestness as notified in the table within 7 days from the date of execution of agreement, above failing which it would be presumed that he is not interested in the work and action will be taken to get the work executed through alternate agency at the risk and cost of the Successful Bidder.
10. The Bruhat Bangaluru Mahanagara Palike reserves the right to accept/reject any or the entire tender's without assigning any reasons.
11. In view of implementation of e-payment facility for e-tendering activity in BBMP, The Contractors interested in Bidding for the work mentioned above may log on to BBMP e-tender portal to initiate the transaction i.e., download the application forms, The contractor has to make the payment for tender application fee and for EMD for the concerned tender. The contractor then proceeds towards the payment options. The payment may be made over the internet using the Credit Card/Debit Card or through RTGS challan system by downloading from the e-Tender Portal. Failure to comply with the said conditions, the tender will be rejected.
17. The defect liability period for Civil works & Asphalt works upto 20mm thick maintenance period is one year & Asphalt thickness more than 20mm thick maintenance period is two year from the date of final bill. The E.M.D and Performance security amount will be refunded only after the defect liability period.
18. Tenderers can submit the **tenders for all the works, However this is subject to fulfillment of tender capacity condition as per standard tender document for procurement of works K/W-1.**
19. The tenders will be opened on the due date and time of opening indicated in the tender document.
20. **Deadline for submission of tender**

Tenders must be submitted to BBMP at the website [www.tenderwizard.com/BBMP](http://www.tenderwizard.com/BBMP) address specified before 19-08-2013 upto 4.00 pm. In the event of the specified date for the submission of tenders being declared a holiday for the BBMP, the tenders will, be received up to the appointed time on the next working day.

BBMP at its discretion may review the various terms and conditions of tender and extend the deadline for submission of tenders by issuing an amendment, in which case all rights and obligations of the BBMP and the Tenderers previously subject to the original deadline will then be subject to the new deadline. Tenders will not be accepted after the time fixed for receipt of bids.

22. **Quantities of work: The tenderer has to submit the tender as per quantities indicated Schedule 'B' only.** However, the tenderer has to make his pre-bid survey for complete re-verification of quantities and site condition before submitting the tender.
