1. Any reputed Individual / Company registered with BBMP / CPWD / KPWD / Railways / MES or any State Government Organizations are eligible to apply.
2. No Joint Venture / Consortium is permissible.
3. Certified Xerox copy of the valid Registration Certificate issued by the Bruhat Bangalore Mahanagara Palike for the block period of 2010-2015 should be enclosed with the tender documents.
4. The Tender Document will form the part and parcel of the Agreement.
5. The Bruhat Bangalore Mahanagara Palike reserves the right to accept / reject any or all the Tenders without assigning any reasons.
6. The Tender will remain valid for **90 Days** after the Deadline Date for Tender Submission.
7. The Work shall be commenced with all Men and Machinery within 7 days from the Date of Work Order, failing which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tenderer.
8. Tenderer who have the works Pending with them will not be entertained.
9. The Tender Accepting Authority shall have the power to accept to reject any tender without assigning any reason thereof.
10. The Income Tax at the rate of 2.30%, KST at 4% and Cess at 1% will be Deducted and certificate will be issued in favour of the Contractor from every running bill / final bills of the contractor:
11. The rates quoted in the schedule shall be inclusive of all taxes applicable.
12. Black Listed Contractors / in Govt. / Quasi Govt. / Boards / BBMP etc., are not eligible to quote, if found such Tenders will be rejected.
13. The successful Tenderer shall pay the Difference Cost if any within 7 days from the date of receipt of the intimation from this Office, failing which the Tender will get cancelled without any further notices.
14. The successful Tenderer shall execute an Agreement within **7 days** from the date of receipt of the intimation from this Office, failing which the Tender will deem to be get cancelled.
15. As per Government order no. LD 300/LET/2006, dt: 18/01/2007, 1% of the Estimated Cost will be deducted and remitted to Karnataka State Building & Other Construction Employees Welfare Board.
16. Sub-Letting of work is prohibited.
17. The defect liability period for Civil works & Asphalt works upto 20mm thick maintenance period is one year & Asphalt thickness more than 20mm thick maintenance period is two year from the date of final bill. The E.M.D and Performance security amount will be refunded only after the defect liability period.
18. Tenderers can submit the tenders for all the works, However this is subject to fulfillment of tender capacity condition and all as per standard tender document for procurement of works K/W-1
19. Frequency of the quality test of all the materials and other tests have to be conducted by the contractor as per MORT&H ( IV th Revision) I.R.C. guidelines and other relevant Indian standards in his laboratory or any other laboratory assigned by BBMP on his own cost in presence of Engineer / consultants appointed by BBMP
20. Works costing more than Rs.100.00 Lakhs are subject to third party test and the cost of the same shall be borne by the contractor.
21. For Asphalt works i.e., BM and BC those who own their hot mix plant 40-60 TPH & mechanical paver only shall apply.
