The Executive Engineer Project (West) Division invites tenders from eligible tenderers, registered in appropriate class in Bruhat Bangalore Mahanagara Palike / KPWD / CPWD / Railways / MES / any state or Central Govt. Organisation for the works detailed in the Table below. The tenderers may submit tenders for any or all of the works given in the Table.

a. After login to Contractors, Please scroll down to the right side bottom to see List of Tenders, Please click there to find the details of NIT and download copy of the tender. The tender can be downloaded in the portal as per prescribed date and time published in the portal. Only Interested Contractors who wish to participate should remit on line transaction fee for tender after registering in the portal. The transaction fee is non-refundable if you wish to participate.

Tenders must be accompanied by earnest money deposit which should be paid online through e-Procurement portal using any of the following payment modes: Credit Card Direct Debit, National Electronic Fund Transfer (NEFT), Over the Counter (OTC).

Tenders must be electronically submitted (on-line through internet) within the date and time published in e-procurement portal. Tenders will be opened at prescribed time and date in the e-procurement portal, in the presence of the Tenderers who wish to attend at the OFFICE OF THE EXECUTIVE ENGINEER, Project (West) Bruhath Bangalore Mahanagara Palike, Dasappa Maternity Home premises, Bangalore-02.

## **Eligibility Criteria for Two Cover System Only:**

- 1. The Contractor should have executed 80% work of the amount put to tender of similar type of work. Certificate to this effect from competent authority not below the rank of Executive Engineer shall be furnished along with technical bid.
- 2. Present net worth should not be less than 75% of amount put to tender.
- 3. Line of credit issued by any scheduled bank for the minimum value of 50% the value of work tendered.
- 4. Annual turnover should not be less than twice the amount put to tender in previous three financial years.
- 5. Latest income tax clearance certificate from the income tax department.
- 6. Provisional Programme for completion of various items of work.
- 7. The Contractor should furnish List of Technical staff & machineries
- 8. The Contractor should have Class 1 A & above Civil contract license issued by BBMP / CPWD / KPWD / Railways / MES or any State Government Organizations.
- 9. No joint venture or consortia is permissible.
- 10. The tender is of two cover system.
  - i) Bidders / Contractors should attach all the scanned copies of technical documents / certificates pertaining to their eligibility criteria mentioned above in the website itself, failing which the bid will not be considered (Technical bid)
- 11. For those contractors whose Technical bids do not satisfy the eligibility criteria, their financial Bids will not be opened.
- 12. The validity of tender is 3 months from the date of opening of tender.
- 13. Tender documents may be downloaded from Government of Karnataka e-Procurement website https://eproc.karnataka.gov.in under login for Contractors. Aspiring Bidders/Contractors who have not registered in e-procurement should register before participating through the website <a href="https://eproc.karnataka.gov.in">https://eproc.karnataka.gov.in</a>.

#### **TERMS & CONDITIONS:**

- 1. Any reputed Individual / Company registered with BBMP / CPWD / KPWD / Railways / MES or any State Government Organizations are eligible to apply.
- 2. No Joint Venture / Consortium is permissible.
- 3. Certified Xerox copy of the valid Registration Certificate issued by the Bruhat Bangalore Mahanagara Palike for the block period of 2005-2010 should be enclosed with the tender documents and the valid electrical inspectorate license
- 4. Total Estimate cost of this work is Rs.411.00 Lakhs, The Amount allotted for Rs.200.00 Lakhs in 2010-11 Budget & remaining Rs.211.00 Lakhs will be provided in next probable allocation.

- 5. The Tender Document will form the part and parcel of the Agreement.
- 6. As per Special Commissioner (project) Circular No.ION/PR/(1)/08/07-08, Dt:16/10/07, and Engineer-In-Chief Order No: EIC/EC/PR/606/07-08, dated: 24/9/2007. The following conditions are stipulated in the tender, The amount quoted by the tenderer is less than the tender amount, such tenderer shall remit the difference amount before signing the Agreement, in the form of DD in favour of THE COMMISSIONER, BRUHAT BANGALORE MAHANAGARA PALIKE, BANGALORE. This difference amount will be returned after, satisfactory completion of the work only and failure to comply the said conditions, the tender will be rejected
- 7. The Bruhat Bangalore Mahanagara Palike reserves the right to accept / reject any or all the Tenders without assigning any reasons.
- 8. The Tender will remain valid for 90 Days after the Deadline Date for Tender Submission.
- 9. The Work shall be commenced with all Men and Machinery within 7 days from the Date of Work Order, failing which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tenderer.
- 10. Tenderer who have the works Pending with them will not be entertained.
- 11. The EMD and SD amount will be returned after successful completion of ONE year.
- 12. The Tender Accepting Authority shall have the power to accept to reject any tender without assigning any reason thereof.
- 13. The Tenderer shall give one year Guarantee for the instruments and maintain for one year and replace such parts, fused out, burnt out and defective parts thereon at free of cost.
- 14. Certified Xerox copies of the documents shall be enclosed along with the Tender, failing which the tender will be rejected.
- 15. The Income Tax at the rate of 2.30%, KST at 4% and Cess at 1% will be Deducted and certificate will be issued in favor of the Contractor from every running bill / final bills of the contractor:
- 16. The rates quoted in the schedule shall be inclusive of all taxes applicable.
- 17. The work shall be carried out as per the directions of the BBMP Engineer in-charge
- 18. Black Listed Electrical Contractors / in Govt. / Quasi Govt. / Boards / BBMP etc., are not eligible to quote, if found such Tenders will be rejected.
- 19. The successful Tenderer shall pay the Difference Cost if any within 7 days from the date of receipt of the intimation from this Office, failing which the Tender will get cancelled without any further notices.
- 20. As per Government order no. LD 300/LET/2006, dt: 18/01/2007, 1% of the Estimated Cost will be deducted and remitted to Karnataka State Building & Other Construction Employees Welfare Board.
- 21. Sub-Letting of work is prohibited.
- 22. The defect liability period for Civil works & Asphalt works upto 20mm thick maintenance period is one year & more than 20mm thick maintenance period is two year from the date of final bill. The E.M.D and S.D. will be refunded only after the defect liability period.
- 23. Frequency of the quality test of all the materials and other tests have to be conducted by the contractor as per MORT&H ( IV th Revision) I.R.C. guidelines and other relevant Indian standards in his laboratory or any other laboratory assigned by BBMP on his own cost in presence of Engineer / consultants appointed by BBMP
- 24. The successful Tenderer shall execute an Agreement within 7 days from the date of receipt of the intimation from this Office, failing which the Tender will deem to be get cancelled.
- 25. The sample & make shall be got approved by the undersigned before Executing the work.

- 26. Further Details of the Work can be obtained from the Office of Executive Engineer, Project (West) Division, Dasappa Maternity Home compound Near Town hall Bruhat Bangalore Mahanagara Palike, Bangalore on all Working Days During office hours.
- 27. All the participants should produce all the original documents for verification whenever necessary.
