Aspiring Bidders/Contractors who have not registered in e-procurement should register before participating through the website <a href="https://eproc.karnataka.gov.in">https://eproc.karnataka.gov.in</a>.

- 3. The Bruhat Bangalore Mahanagara Palike reserves the right to accept / reject any or all the Tenders without assigning any reasons.
- 4. The Tender will remain valid for **90 Days** from the Date of Opening of bid.
- 5. The Work shall be commenced with all Men and Material within 7 days from the Date of Work Order issued, failing which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tender & his EMD will be forfeited.
- 6. Submission of EMD is mandatory and which will be forfeited if the tenderer is not quoted is rates / not participated.
- 7. Refund of EMD will be only after the completion of the defect liability period.
- 8. The Bruhat Bangalore Mahanagara Palike Tender document is part and partial of the agreement. **The successful tenderer** will have to execute agreement with BBMP without assigning any reasons other wise his EMD will be forfeited.
- 9. If the bidder quotes the lesser amount when compare to the tender amount, difference amount has to be paid through D.D. in favour of Commissioner, BBMP before execution of agreement.
- 10. Any reputed Individual/ company registered with BBMP/CPWD/ KPWD/ Railways/ MES or any State Government Organization are eligible to apply.
- 11. No Joint Venture / Consortium are permissible.
- 12. The Tenderer shall have executed and completed successfully in any one financial year during block period of previous five financial years. i.e., between 2007-08 to 2011-12 atleast a single work of value not less than 50% value of tender amount should be excuted and completed. In support of this, the Tenderer shall furnish a Work Completion

- Certificate duly certified by the competent Authority not below the Rank of Executive Engineer shall be uploaded.
- 13. The Bidder should have completed work in previous two years for double the amount of tender amount.
- 14. Tenderer shall furnish list of technical staff required for the work (Organization chart), Equipment, men and Machineries going to deploy by him / her.
- 15. The tenderer in its name should have in the last five years i.e., between 2007-08 to 2011-12 achieved in atleast two financial years a minimum financial turnover usually not less than two times the estimated annual payment.
- 16. Bidders/Contractors Should attach all the Scanned copies of technical documents/certificates pertaining to their eligibility criteria mentioned above in the website itself, failing which, the bid will not be considered. The original documents should be produced for verification at any stage of tender process as and when sought for, failing which, the bids are liable for disqualification.
- 17. Rates shall be quoted in Tender Schedule-B in the e-Procurement portal only.
- 18. **Performance security**: Shall be paid within 20days of the receipt of the letter of acceptance, the successful tenderer shall deliver to the employer a security deposit if any of the forms for an amount equivalent to 5% of the contract price plus additional security for unbalanced tenders in accordance with clause **25.5** of ITT & Clause 44 of the conditions of contract for all works.
- 19. **Conditional tenders will not be accepted.** As per Govt order No.LD/300/LET/2006, Dated:18/01/2007 and Addl. Commissioner (Finance) No.BBMP/CAO/PR/07-08, Dt:03/08/07 the building construction labourers welfare cess (1% of Est. Cost) will be deducted from the Building and other construction works in every running bill and also in the final bill of the Contractor.
- 20. The Commissioner, BBMP, Bangalore reserves the right either to reject or to accept any tender without assigning any reason before or after finalization of the Tender.
