- 3. Technical Bid opening date : 09-04-2013 at 4.30 PM. Financial Bid opening date: Will be intimated later.

Eligibility Criteria:

- The Tenderer shall have executed and completed successfully a single work of value not less than 80% value of amount put to tender in any one financial year during block period of previous five financial years. i.e., between 2007-08 and 2011-12. In support of this, the Tenderer shall furnish a Work Completion Certificate duly certified by the competent Authority not below the Rank of Executive Engineer shall be uploaded along with Technical Bid. The Work Completion Certificate shall mention the Nature of Work, the Date of Commencement and Date of Completion of the work.
- 2. Each tenderer in his name should have achieved in at least two financial years a minimum turn over (In all classes of civil engineer construction works only) of not less than two times the estimated annual payments in the last five years i.e., 2007-08 and 2011-12.
- 3. Tenderer shall furnish list of Equipment and Machineries possessed by him / her.
- 4. The bidder shall have Present net worth not less than 75% of amount put to tender.
- 5. The bidder shall have achieved at least two financial years a minimum financial turnover not less than 2 times the estimated annual payment under this contract in all civil Engineering works in last 5 years. The bidder shall submit balance sheets as proof of having annual turn over as above, which shall be duly certified by a Chartered Accountant.
- 6. The bidder must submit line of Credit for an amount equal to estimated cash flow for 3 months in peak construction period issued by Nationalized/Scheduled Bank of original, for the tendered work.
- 7. The bidder shall submit latest income tax paid certification from the income tax department.

General Conditions.

- 4. The Tender will remain valid for 90 Days from the Date of Opening of Financial bid.
- 5. The Work shall be commenced with all Men and Material within 7 days from the Date of Work Order, failing to which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tendered.

- 7. Any reputed Individual/ company registered with BBMP/CPWD/ KPWD/ Railways/ MES or any State Government Organization are eligible to apply.
- 8. No Joint Venture / Consortium are permissible.
- 9. The Tender is a Two Cover Tenders System.
- 10. Only bidders who qualifies in technical evaluation (cover no. 1) are eligible for opening the financial bids (cover no.2).
- 11. The bidder must submit line of Credit for an amount equal to estimated cash flow for 3 months in peak construction period issued by Nationalized/Scheduled Bank of original, for the tendered work.
- 12. The intending tenderers shall furnish a cash flow chart on month basis for the entire period of execution of the work.
- 13. The bidder must submit Provisional programme for completion of various items of work.
- 14. Bidders/Contractors Should attach all the Scanned copies of technical documents/certificates pertaining to their eligibility criteria mentioned above in the website itself, failing which, the bid will not be considered. (Technical Bid). The original documents should be produced for verification at any stage of tender process as and when sought for, failing which, the bids are liable for disqualification.
- 15. Rates shall be quoted in Tender Schedule-B (Financial Bid). In the website itself.
- 16. The Bruhat Bangalore Mahanagara Palike Tender document is part and partial of the agreement. The successful tenderer will have to execute agreement with BBMP without assigning any reasons.
- 17. In case tenderer quotes lesser amount than the estimated amount, before signing of the agreement, tenderer should furnish a Demand Draft for difference of amount in favour of **Commissioner BBMP**.
- 18. Date for opening of financial bid will be intimated to Bidders who qualify in technical evaluation.
- 19. Conditional tenders will not be accepted.
