**(Through GOK e-Procurement Portal <http://eproc.karnataka.gov.in> only)**

1. The Executive Engineer (Project Division), BBMP, Bangalore. invites tenders from eligible contractors registered in Bruhat Bangalore Mahanagara palike or equivalent registration with CPWD / KPWD / Railways / MES / National Highway or any state Government Organisations for the construction of works detailed in the table below. The tenderers may submit tenders for works given in the table through e-procurement portal of the Government of Karnataka (viz <https://eproc.karnataka.gov.in>). The Tenderers are advised to note the minimum qualification criteria specified in clause 3 of the Instructions to Tenderers to qualify for award of the contract (standard Tender Document – KW2).
2. Tender documents may be downloaded from the e-procurement portal of the Government of Karnataka from : **18.07.2013 to 25.07.2013**
3. Tenders must be accompanied by earnest Money deposit specified for the work in the table below. Earnest money deposit will have to be in any one of the forms as specified in the Tender document and shall have to be valid for 45 days beyond the validity of the tender.
4. Tenders must be submitted online through e-procurement portal on or before 1600 hours on :**29.07.2013** And the opening of tenders will be as per the e-procurement portal guidelines.

**For Single cover Tenders only Financial Bid may be Submitted**

1. Any reputed Individual / Company registered with BBMP / CPWD / KPWD / Railways / MES or any State Government Organisations are eligible to apply.
2. No Joint Venture / Consortium is permissible.
3. The Tenderer shall have executed and completed successfully in the last five years i.e. between 2008 – 2009 and 2011 – 2012 a single work of similar nature of value not less than 80% estimated value of Contract. In support of this, the Tenderer shall furnish a Work Completion Certificate duly certified by the Competent Authority along with Technical Bid.
4. The Tenderer shall furnish the List of Man Power, Equipment and Machineries possessed by him / her.
5. The Tender is a two cover system consisting of
  - i. The Tenderer shall upload the following Documents in one cover inscribing the Cover as “Cover – 1 –Technical Documents (Technical Bid)”.
    1. Tenderer should submit their EMD and tender processing fee in the form of e-payment through e-Procurement Portal.
    2. Bidders/Contractors can access tender documents on the website, fill them and submit the completed tender document into electronic tender on the website <https://eproc.karnataka.gov.in/>.
      - a. Work Completion Certificate for having completed at least one work of similar nature of value not less than 80% estimated value of Contract, certified from the Competent Authority not below the Rank of Executive Engineer shall be enclosed. The Work Completion Certificate shall mention the Nature of Work, Items of Work executed and the Date of Commencement and Date of Completion of the Work.
    - ii. The Tenderer shall upload the following Document in another cover inscribing the Cover as “Cover – 2 (Financial Bid)”.
      - a. Rates quoted in Bill of Quantities.
6. For those Tenderers whose Technical Bids do not satisfy the Eligibility Criteria as mentioned above, their Financial Bids will not be opened.
7. Tender documents may be downloaded from Government of Karnataka e-Procurement website <https://eproc.karnataka.gov.in> under login for Contractors. Aspiring Bidders/Contractors who have not registered in e-procurement should register before participating through the website <https://eproc.karnataka.gov.in>.

9. The successful Tenderer shall enter into the Agreement with the BBMP within 7 days of receipt of intimation. The Tender Document will form the part and parcel of the Agreement.

10. The Bruhat Bangalore Mahanagara Palike reserves the right to accept / reject any or all the Tenders without assigning any reasons.
11. The Tender will remain valid for **90 Days** from the Date of Opening of Tender.
12. The Work shall be commenced with all Men and Machinery within **7 days** from the Date of Work Order, failing which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tenderer.

If the rate/amount quoted by the tenderer is less than the rate/amount of the Tender amount, such tenderer, while submitting the tender shall remit the difference amount in form of DD in favour of **Commissioner, Bruhat Bangalore Mahanagara Palike**, along with separate EMD amount". This difference amount will be returned after satisfactory completion of the work only. Failure to comply with the said conditions, the tender will be rejected
