Bruhat Bangalore Mahanagara Palike, Bangalore invites tenders from eligible tenderers for the works detailed in table below. The tenderers may submit tenders for the work given in the table in appropriate class registered in Bruhat Bangalore Mahanagara Palike/ KPWD/ CPWD/ Railways/MES/any State or Central Government Organization, through electronic tendering system (e-tender).

These tenders are E-Tendering in order to enhance the transparency in the tendering process.

Tender documents can be obtained from <http://www.tenderwizard.com/BBMP> where electronic tender form is provided from **11-09-2013 to 13-09-2013**, for a non-refundable fee as indicated in the Table below, in the form of Demand Draft/Pay Order Only on any Nationalized/ Scheduled bank payable at Bangalore in favor of Executive Engineer, Project-West Division, Bruhat Bangalore Mahanagara Palike, Bangalore. or The Commissioner, BBMP Bangalore.

Tenders must be accompanied by earnest money deposit (EMD), specified for the work in the Table below. Earnest money deposit will have to be in anyone of the forms as specified in the Tender document and shall have to be valid for 90 days beyond the validity of tender .

Tenders must be submitted to <http://www.tenderwizard.com/BBMP> only on or before 4.00 P.M. hours on **17-09-2013** and will be opened on the same day at 04.30 P.M. hours in the presence of the tenderer who wish to attend.

If the office happens to be closed on the date of receipt of the tenders on specified, the tenders will be received and opened on the next working day at the same time. And venue other details can be seen in the tender documents.

TERMS AND CONDITIONS:

1. The Bid Security (EMD) should be in the form Online system as per e-tendering portal as per Chief Finance Officer, BBMP Circular No.CFO/31/Training/2010, dated:03-09-2012
2. No Joint Venture / Consortium is permissible.
3. Conditional Tenders will not be accepted.
4. The Contractor is not eligible for submission of application for tender documents if he has not put the tender after purchase of the tender document continuously for three times.
5. Sub-Letting of work is prohibited.
6. The Contractors having the PAN No & TIN No are only eligible for the tender.
7. The Competent authority of the Bruhat Bangalore Mahanagara Palike reserves the right to accept or reject any or all the tenders without assigning any reason thereon.
8. The Income Tax and K.S.T. as applicable will be deducted from every running and final bill of the contractor.
9. The validity of the tender is 90 days from the date of receipt of the same .If it is required for further period the same has to be extended by them, on request from this office.
10. The Contractor should pay the difference amount if quoted below the Tender cost at the time of Execution of Agreement.
11. The contractors should maintain the quality of work as per the standard specifications.
12. Tender capacity of the Contractor will be based on qualification information vide Clause 3 of the Instructions to the Contractors.
13. The N.S.C. and F.D.R. will not be accepted for E.M.D.
14. As per Govt order No. LD/300/LET/2006.Dated: 18.01.2007 and Addl, Commissioner (Finance) No. BBMP/CAO/PR/06/07-08 dated: 03.08.07 the Building Construction Labourers Welfare Cess (1% of Estimated cost) will be deducted from building and other construction works of every running and final bill of the Contractor.
15. The tenderers will have to furnish list of machineries and equipments along with a copy of the Registration Certification at the time of submitting application for tender forms.
16. The defect liability period for completed works is One year for Civil works / Two year for Asphaltting & chip carpeting works from the date of final bill. The E.M.D. and S.D. will be refunded only after the defect liability period.
17. As per Government Circular No. CI226 MMN 2006 Dt: 04.12.07 the contractors are liable to pay royalty in terms of the contract if they are not able to produce the materials purchased document / MDP's from where they purchase.
18. Those who wish to undergo training should confirm through telephone with the undersigned and "KEONICS". During the training, training manual and CD will be given to each contractor for participating through electronic tendering method. During the training, User ID, Password will be issued to the supplier.
19. Aspiring bidders/Contractors who have not obtained the user ID & Password for participating in Electronic Tendering (e – tendering) in Bruhat Bangalore Mahanagara Palike, may now obtain the same from the website www.tenderwizard.com/BBMP through link "Register Me".

20. Aspiring bidders/Contractors will be enabled after registering and only after receiving the Demand Draft of Rupees 1655/- (Rs. One Thousand Six Hundred & fifty five only) towards the Annual registration Fee to Electronic Tendering Portal. Demand Draft Should in Favor of "KSEDC LTD " Payable at Bangalore.
21. Bidders/Contractors can access e-tender form (tender document) by making payment of amount as shown in the above table towards the cost of documents through Online system as per e-tendering portal as per Chief Finance Officer, BBMP Circular No.CFO/31/Training/2010, dated:03-09-2012 The e-tender document can be accessed / downloaded only after receipt of DD towards tender document fee.
22. EMD shall be paid only Online system as per e-tendering portal as per Chief Finance Officer, BBMP Circular No.CFO/31/Training/2010, dated:03-09-2012
23. In case of E-tendering Tenderers have to access tender documents on the website, fill them and submit the completed tender document into electronic tender on the website itself. The EMD shall be paid Online system as per e-tendering portal on or before 16:00 hours on 17-09-2013, failing which the firm/contractor will be disqualified.
24. In case of E-tendering Bidders/Contractors Shall attach all the Scanned copies of certificates pertaining to their pre-qualification and service literature and any other tender related documents if required by the Department failing which their tenders will be disqualified.
