Organisation for the works detailed in the Table below. The tenderers may submit tenders for any or all of the works given in the Table.

The tender can be downloaded in the portal as per prescribed date and time published in the portal. Only Interested Contractors who wish to participate should remit on line transaction fee for tender after registering in the portal. The transaction fee is non-refundable if you wish to participate.

Tenders must be accompanied by earnest money deposit which should be paid online through e-Procurement portal using any of the following payment modes: Credit Card Direct Debit, National Electronic Fund Transfer (NEFT), Over the Counter (OTC).

Tenders must be electronically submitted (on-line through internet) with in the date and time published in e-procurement portal. Tenders will be opened at prescribed time and date in the e-procurement portal , in the presence of the Tenderers who wish to attend at the OFFICE OF THE EXECUTIVE ENGINEER, Bruhath Bangalore Mahanagara Palike, Project (West), Bangalore-02

TERMS AND CONDITIONS:

TERMS & CONDITIONS:

- 1. The bidder shall be running a registered **Security Service** from past 5 Years, preferably headed by the person, who have similar nature of work.
- Any reputed Individual / Company registered with BBMP / CPWD / KPWD / Railways / MES
 or any State Government Organizations are eligible to apply if they executed any similar
 type of Security Work in previous 5 years.
- 3. The agency should be registered with I.T, E.S.I, P.F, Labour Department and other statutory authority of Government of Karnataka.
- 4. Bidder should be enclose previous work experience certificate of State Government/Public Sector under taking/ any other reputed private Organization.
- 5. Agency should submit their company profile with previous year audit report.
- 6. Latest income tax clearance certificate from the income tax department.
- 7. The agency shall solely be responsible for the payment of mini wages, allowance, bonus, gratuity and other benefits as per minimum wages act to its employees and responsible for the welfare of its employees as per the various labour legislations and regulations in force from time to time.
- 8. The agency shall provide the required number of personnel to the BBMP and shall arrange replacement as necessary at its own expenses, in case of sickness, absenteeism leave of its employees or the absence of the personnel for any reason whatsoever.
- 9. The agency shall arrange for periodical in inspections of the BBMP officers. The departmental officers will also undertake surprise inspection to check day/ night duty performance by the Security persons deployed by the agency. The Security agency should arrange daily mustering from department officials and **SUBMIT DAILY ATTENDANCE ABSTRACT TO THE OFFICER IN CHARGE.**
- 10. No Joint Venture / Consortium is permissible.
- 11. Conditional Tenders will not be accepted.
- 12. The details of Security Guards along with Photos and I.D.Proof should be submitted at the time of Agreement.
- 13. If any changes made in the given format of Security Guards, then it should be brought to the Notice of Division Office along with Photos and I.D. Proof.
- 14. If any violation of law occurred during or after the execution of work regarding the payment towards individuals from the contractor, only the contractor is held responsible for those violations and B.B.M.P. or any its faculty/officials are not responsible for such violations.
- 15. One shift is equal to 8 hours and Security Service has to be furnished by the Agency around the clock.
- 16. The Agency is held responsible for any circumstances, which proves the failure in Security Services.

- 17. The Agency should maintain the daily must-role (Attendance) and the same has to be submitted to the Division Office.
- 18. The Agency has to provide necessary items/accessories/equipments etc., to each individual security person by his own cost. No extra cost will be filed for the same.
- 19. In any extreme circumstances, the activities must be brought to the divisional office without any delay.
- 20. The Agency should provide the facilities to each individual security person as per the Labour Act, failing which the agency is directly responsible for the same and BBMP or its officials are not responsible for the same.
- 21. The Agency should provide the Security Services as per the time to time directions of Engineer in charge.
- 22. Certified Xerox copy of the valid Registration Certificate issued by the Bruhat Bangalore Mahanagara Palike for the block period of 2005-2010 should be enclosed with the tender documents and the valid electrical inspectorate license
- 23. The Tender Document will form the part and parcel of the Agreement.
- 24. As per Special Commissioner (project) Circular No.ION/PR/(1)/08/07-08, Dt:16/10/07, and Engineer-In-Chief Order No: EIC/EC/PR/606/07-08, dated: 24/9/2007. The following conditions are stipulated in the tender, "The amount quoted by the tenderer is less than the tender amount, such tenderer shall remit the difference amount before signing the Agreement, in the form of DD in favour of EXECUTIVE ENGINEER, PROJECT (WEST) DIVISION, Bruhat Bangalore Mahanagara Palike, Project (West), Bangalore-02. This difference amount will be returned after, satisfactory completion of the work only and failure to comply the said conditions, the tender will be rejected
- 25. The Bruhat Bangalore Mahanagara Palike reserves the right to accept / reject any or all the Tenders without assigning any reasons.
- 26. The Tender will remain valid for 90 Days after the Deadline Date for Tender Submission.
- 27. The Work shall be commenced with all Men and Machinery within 7 days from the Date of Work Order, failing which it would be presumed that the Successful Tenderer is not interested in the Work and Action will be taken to get the Work executed through Alternate Agency at the risk and cost of the Former Tenderer.
- 28. Tenderer who have the works Pending with them will not be entertained.
- 29. The EMD and SD amount will be returned after successful completion of ONE year.
- 30. The Tender Accepting Authority shall have the power to accept to reject any tender without assigning any reason thereof.
- 31. The Tenderer shall give one year Guarantee for the instruments and maintain for one year and replace such parts, fused out, burnt out and defective parts thereon at free of cost.
- 32. Certified Xerox copies of the documents shall be enclosed along with the Tender, failing which the tender will be rejected.
- 33. The Income Tax at the rate of 2.30%, KST at 4% and Cess at 1% (As applicable from time to time) will be Deducted and certificate will be issued in favor of the Contractor from every running bill / final bills of the contractor:
- 34. The rates quoted in the schedule shall be inclusive of all taxes applicable.
- 35. The work shall be carried out as per the directions of the BBMP Engineer in-charge
- 36. Black Listed Electrical Contractors / in Govt. / Quasi Govt. / Boards / BBMP etc., are not eligible to quote, if found such Tenders will be rejected.
- 37. The successful Tenderer shall pay the Difference Cost if any within 7 days from the date of receipt of the intimation from this Office, failing which the Tender will get cancelled without any further notices.

- 38. As per Government order no. LD 300/LET/2006, dt: 18/01/2007, 1% of the Estimated Cost will be deducted and remitted to Karnataka State Building & Other Construction Employees Welfare Board.
- 39. Sub-Letting of work is prohibited.
- 40. The defect liability period for Civil works & Asphalt works upto 20mm thick maintenance period is one year & more than 20mm thick maintenance period is two year from the date of final bill. The E.M.D and S.D. will be refunded only after the defect liability period.
- 41. Frequency of the quality test of all the materials and other tests have to be conducted by the contractor as per MORT&H (IV th Revision) I.R.C. guidelines and other relevant Indian standards in his laboratory or any other laboratory assigned by BBMP on his own cost in presence of Engineer / consultants appointed by BBMP
- 42. The successful Tenderer shall execute an Agreement within 7 days from the date of receipt of the intimation from this Office, failing which the Tender will deem to be get cancelled.
- 43. The sample & make shall be got approved by the undersigned before Executing the work.
- 44. Further Details of the Work can be obtained from the Office of Executive Engineer, Project (West) Division, Dasappa Maternity Home compound Near Town hall Bruhat Bangalore Mahanagara Palike, Bangalore on all Working Days During office hours.
- 45. All the participants should produce all the original documents for verification whenever necessary.
- 46. Conditional tenders will not be accepted.
- 47. The validity of tender is 3 months from the date of opening of tender.
