#### TERMS AND CONDITIONS

1. Any reputed Individual / Company registered with BBMP / CPWD / KPWD / Railways / MES or any State Government Organizations are eligible to apply.
2. No Joint Venture / Consortium are permissible.

3. Tenderer should submit their EMD and tender processing fee in the form of e-payment through e-Procurement Portal (Credit Card, Direct Debit, National Electronic Fund Transfer (NEFT), and Over the Counter (OTC).
4. Bidders/Contractors can access tender documents on the website, fill them and submit the completed tender document into electronic tender on the website <https://eproc.karnataka.gov.in/>.
5. Scope of Work: The work involves Construction of **Building with frame structure, Arch bridge, boat bay, compound wall, water supply and sanitary, rain water disposal, Electrical work, roads and drain and bund.**
6. Essential conditions: The tender shall fulfill the following criteria for getting pre qualified for the works as under
7. Shall have minimum Annual turn over not less than two times the amount put to tender during two of the last five financial years.
8. Shall produce line of credit from any of the Nationalized bank for **30%** of the amount put to tender.
9. Should have completed similar one single work costing **80%** of the amount put to tender..
10. Should not incurred any loss in more than a year during the last 3 years ending 31st March 2012.
11. Possessing (ownership) requisite plant and machinery for completing the work. Document showing the ownership like preformed invoice & delivery notes needs to be furnished along with tender.
12. The successful bidder should pay 1% towards building and other construction workers welfare cess under Central Government Notification, Dt:26-09-2006 for the tender amount which will be deducted in work bills.
13. The bid Documents consists of Pre-qualification containing conditions of Contract and technical Specifications and Bill of quantities.
14. Based on an assessment of the information furnished in the cover -1 viz, Pre-Qualification Documents those who prima-facie satisfy the eligibility criteria will be qualified and cover -2 Containing the financial bids shall be Considered for opening and evaluation.
15. The Tender is a Two Cover Tenders System Consisting of
  - a) Technical Bid: The Technical bid should contain EMD, details of technical, financial and managerial capabilities to Execute of the work as per the requirements.
  - b) Financial Bid: The financial bid should contain only the price bid. For such of those contractors, whose technical bids do not satisfy the eligibility, their financial bids will not be opened and the tenders will summarily be rejected.
16. Non submission of the tender attracts action as per conditions stipulated in the rules of registration of Contractors.
17. Tender documents may be downloaded from Government of Karnataka e-Procurement website <https://eproc.karnataka.gov.in> under login for Contractors. Aspiring Bidders/Contractors who have not registered in e-procurement should register before participating through the website <https://eproc.karnataka.gov.in>.

21. The work should be commenced with all earnestness within seven days from the date of work order failing which it would be presumed that he is not interested in the work and action will be taken to get the work executed through alternate agency at the risk and cost of the former tenderer.
