TERMS AND CONDITIONS OF TENDER NOTIFICATION

- 1 Conditional tenders will not be accepted.
- 2 The contractor has to make own arrangements for procurement of all materials. There is no departmental supply of materials. Contractor should procure materials with BIS or other relevant standards & obtain necessary quality control tested certificates from authorized quality control authority.
- 3 The contractor is not eligible for submission of application for tender form if he has not participated in tenders after purchase of the tender document continuously for three times.
- 4 Sub-letting of work is prohibited.
- 5 Any corrigendum/Modification will be notified in the Notice Board of the undersigned.
- 6 As per the Government Order No: LD 300/LET/2006, dtd 18.07.2007 1% of the bill amount will be deducted and remitted to Karnataka State Building & other construction Employees Welfare Board.
- 7 Necessary taxes and other deductions will be made from contractor bills.
- 8 The successful bidder will have to execute an agreement with BBMP within 7 days of receipt of intimation, failing which his tender is liable to be rejected without giving notices and EMD will be forfeited.
- 9 The Bruhat Bangalore Mahanagara Palike reserves the right to accept/reject any or the entire tender's without assigning any reasons.
- 10 The Contractors interested in Bidding for the work mentioned above may submit an application to the undersigned along with cost of Tender Documents as per column 7 of the above table to be paid in the form of Demand Draft or Pay Order drawn in favour of the Commissioner BBMP Bangalore in any Nationalized Bank and obtain approval for registration with authorized e-tendering agency M/s KEONICS, No:24, First Floor, Sudha Complex, 3rd Stage, 4th Block, Basaveshwara Nagar, Bangalore-560 079.
- 11 The tenderers should have to produce contractors registration book issued by the concerned authority for procurement of tender documents. Applicant should submit Proof of registration, latest Income Tax Clearance Certificate, obtained from the Concerned Department while submitting the request for application for the Tender Schedules, otherwise the application will be rejected.
- 12 The requisite EMD as mentioned in column 6 of the above table and if Contractor quotes below the sanctioned rates, then requisite difference amount in the form of DD/Pay Order drawn in favour of the Commissioner, BBMP, A/C EE, Rajajinagar Division in any Nationalized Bank, has to be scanned and uploaded with Schedule-B. The Original DD/Pay Order of the tender diffrence amount should be submitted within three days of receipt of Letter of Acceptance to the undersigned office. If the contractor fails to produce the Tender Difference amount his tender will be disqualified. The DD for difference amount shall not be accepted after completion of the Specified time.
- 13 The Work should be commenced with all earnestness within 7 days from the date of Work Order, failing which it would be presumed that he is not interested in the work and action will be taken to cancel the tender by forfeiting EMD Amount.
- 14 Any other details regarding the above mentioned works & other information may be obtained from the above office during Office hours.
- 15 If the rate/amount quoted by the tenderer is less than the amount put to Tender, then requisite difference amount and EMD in the form of DD in the favour of the Commissioner, BBMP, Bangalore in any nationalized bank has to be scanned and uploaded with Schedule B, The Original DD/Pay Order of the tender diffrence amount should be submitted within three days of receipt of Letter of Acceptance to the undersigned office. If the contractor fails to produce the Tender Difference amount his tender will be disqualified. The DD for difference amount shall not be accepted after completion of the Specified time.

- 16 The tenders shall be strictly adhered to the terms and conditions specified in the tender documents. Lump sum tenders will not be considered. Separate tenders shall be submitted for each work.
- 17 The Contractor should submit the separate application for each work with requisite cost of Tender Document in the form of DD drawn in favour of Commissioner, Bruhat Bangalore Mahanagara Palike within due date specified in the Notification.
- 18 Tenderers can submit the tenders for all the works, however this is subject to fulfillment of Tender capacity condition as per standard tender document for procurement of works K/W-1. The tenders will be opened on the due date and time of opening indicated in the tender document. Tenders must be submitted through e-tender portal at the website www.tenderwizard.com/BBMP. Before 16.03.2013 upto 16.00hrs. In the event of the specified date for the submission of EMD and difference amount for the tenders being declared a holiday/any other technical reason for the BBMP, the tenders will be received up to the appointed time on the next working day. BBMP at its discretion may review the various terms and conditions of tender and extend the deadline for submission of tenders by issuing an amendment, in which case all rights and obligations of the BBMP and the Tenderers previously subject to the original deadline will then be subject to the new deadline. Tenders will not be accepted after the time fixed for receipt of bids.
- 19 Quantities of work: The tenderer has to submit the tender as per quantities indicated in the schedule 'B' only. However, the tenderer has to make his pre-bid survey for complete re-verification of quantities and site condition before submitting the tender.
