- 9 The contractor is not eligible for submission of application for tender form if he has not participated tenders after purchase of the tender document continuously for the three times.

Applicant should submit proof registration, latest Income tax clearance Certificate, obtained from the concerned Department and to submit financial Turnover balance sheet for the last 3 years duly attested by the Charted Accountant while submitting the request for application for the Tender Schedules, otherwise the application will be rejected.
- 18 The work should be commenced with all earnestness within 7 days from the date of Work Order, failing which it would be presumed that he is not interested in the work and action will be taken to get the work executed through alternate agency at the risk and cost of the former Tenderer.
- 19 If the rate/ amount quoted by the tenderer is less than the rate/amount of the Tender amount, such tenderer submit the difference amount at the time of agreement in form of DD in favour of the Commissioner, Bruhath Bangalore Mahangara Palike. This difference amount will be returned after satisfactory completion of the work only. Failure to comply with the said conditions, the tender will be rejected.
