

FORM OF UNDERTAKING FOR RENEWAL OF LICENSE FROM PERSONS ENGAGED IN PACKING, PRESSING, CLEANSING, PREPARING OR MANUFACTURING SELLING BY ANY PROCESS WHATEVER, AMMUNITION, FIRE-WORKS, GUN-POWDER, CHLORATE MIXTURE, FULMINATE OF MERCURY, GUN-COTTON, NITRO-GYLGERINE, NITRO-COMPOUND OR NITRO-MIXTURE AND CHEMICAL OF ALL KINDS INCLUDING PESTICIDE AND CATTLE FEED.

I/ We,.....do hereby solemnly affirm and declare as under:

1. That I/We am/ are carrying on trade of -----at the above premise.
2. That a trade license has been granted to us vide No.----- dated ----- issued by ----- Bangalore Mahanagara Palike on -----
3. That I/We are now applying for the renewal of the trade licence being carried out in the said premise under the automatic trade licence approval scheme.
4. That I have submitted the renewal application on ----- (date of submission) under the said scheme in the prescribed form and remitted the licence fee of Rs..... Rupees.....In favour of Commissioner Mahanagara Palike by demand draft drawn on ----- Branch-----Bank.
5. That I am aware of the conditions prescribed under the byelaws issued under the KMC Act 1976 from time to time commonly for packing, pressing, cleansing, preparing or manufacturing by any process whatever, ammuniton, fire-works, gun-powder, chlorate mixture, fulminate of mercury, gun-cotton, nitro-glycerine, nitro-compound or nitro-mixture, pesticide and cattle feed and I abide to follow these prescribed conditions applicable to the trade carried on by me/us further abid by the conditions detailed herein under:
  - a. No person shall use any premises within the Corporation limits or permit any premises within such limits to be used for storing, packing, pressing, cleansing, preparing or manufacturing by any process whatever, ammuniton, fire-works, gun-powder, chlorate mixture, fulminate of mercury, gun-cotton, nitro-glycerine, nitro-compound or nitro-mixture, pesticide and cattle feed without obtaining a license from the Commissioner.
  - b. Every person shall provide a sufficient and good supply of water in such premises and shall cause such premises to be thoroughly cleansed at least twice in every twenty-four hours or more often, if necessary, and shall prevent any accumulation of filth or refuse therein.

- c. That it is incumbent at all times to adapt and cause to be maintained in good order and efficient action upon such premises all such means and appliances as the health Officer may from time to time, require for the purpose of preventing, any injury to any person employed therein or preventing, abating, or minimizing any nuisance or annoyance to the neighborhood or to the public.
- d. (i) That the floor of all rooms shall be of such construction as to be impervious, easily cleansed, and smooth and in good repair.
- e. That it is incumbent to adopt the best practical means of rendering innocuous all gas, vapour, fumes dust or other impurities arising from any source in such premises.
- f. That in such premises sufficient supply of pure and wholesome water and suitable means and appliances to combat any outbreak of fire shall be provided.
- g. That it shall be incumbent to maintain at all times in good order and efficient action all such means and appliances as are necessary for rendering innocuous of all gas, vapor, fumes, dust or other impurities emitted during any trade process either from the articles operated upon or from the contents of any receptacle upon such premises or from any source whatever connected with the trade.
- h. That every part of the internal surface of the walls and ceiling of every building upon such premises shall lime-washed twice at least every year in the months of April and October and more often if so required by the Health Officers.
- i. That no part of building on such premises shall be used at any time for purposes of human habitation.
- j. That no persons should be permitted to take his meals in such premises.
- k. That suitable means of drainage shall be provided upon or in connection with such premises and maintains it in good condition.
- l. That suitable means of lighting and ventilation shall be provided at the premises so as to permit the escape of all gas, vapour, fumes, dust or other impurities produced or generated in such premises.
- m. He shall cause all refuse or other matter which may have fallen or have been deposited upon any part of such premises to be collected and placed in suitable covered air-tight non-absorbent receptacles to the satisfaction of the Commissioner. He shall cause all such refuse to be removed from such premises at least twice in every 24 hours and shall be disposed of in such manner as may be approved by the Commissioner.
- n. The premises shall be sufficiently spacious and suitable for the purpose of the business intended to be carries on there.

- o. That all refuse or other matter which may have fallen or have been deposited upon any part of such premises to be collected and placed in suitable covered air-tight non-absorbent receptacles to the satisfaction of the Commissioner. Secondly, all such refuse should be removed from such premises at least in every 24 hours and shall be disposed of in such manner as may be approved by the Commissioner.
- p. Every person shall provide a sufficient and good supply of water in such premises and shall cause such premises to be thoroughly cleansed at least twice in every twenty-four hours or more often, if necessary, and shall prevent any accumulation of filth or refuse therein.
- q. That no part of the building in such premises shall be used at any time for purposes of human habitation nor shall such building open into or on any thoroughfare or place of public resort.
- r. That it shall be incumbent to maintain at all times in good order and efficient action all such means and appliances as are necessary for rendering innocuous of all gas, vapor, fumes, dust or other impurities emitted during any trade process either from the articles operated upon or from the contents of any receptacle upon such premises or from any source whatever connected with the trade.
- s. That an inspection/complaints book shall always be available in the trade premises in which customers or Inspecting Officers may enter their remarks or note their complaints and such book shall be open to inspection by any Inspecting Officer of the Health Department of the Corporation.
- t. Besides these conditions imposed, I will also abide by all other regulations under all other Central and State laws connected in the upkeep of hygiene, safety and public health.

In accordance with these prescribed conditions I/we hereby state that I/we have, to the best of our knowledge and belief, have fulfilled the required conditions for the trade carried on by me/us before applying for this renewal of trade licence. If, upon inspection by the Commissioner or his delegated authority, it is found that I/we have not adhered to these conditions imposed, I/we are aware that the licence issued under the Automatic Trade Licence Approval Scheme, will be revoked. Further I /we HEREBY UNDERTAKE to indemnify/and keep harmless the Corporation from all proceedings in Court and before other authorities including the competent authority under appropriate Central and State law in force, all express/losses/claims which the Corporation may incur or become liable to pay as a result or in consequence of the renewal of this trade licence.
