CANNED, EDIBLE OIL STORING, PACKING, PRESSING, CLEANING,  
PREPARING OR MANUFACTURING, BLENDING, PROCESSING STORAGE

I/We wish to apply for the renewal of my/our trade licence. In this regard the following particulars furnished by me are true and correct to the best of my knowledge and belief:

1. That I/We am/ are carrying on trade of -----at the above premise.
2. That a trade license has been granted to me /us vide No.----- dated ----- issued by ----- Bangalore Mahanagara Palike on -----
3. That the above licence granted is due to expire on-----
4. That I/We are now applying for the renewal of the trade licence being carried out in the said premise under the automatic trade licence approval scheme.
5. That I have submitted the renewal application on ----- (date of submission) under the said scheme in the prescribed form and remitted the licence fee of (Rupees.....). in favour of Commissioner, Mahanagara Palike by demand draft drawn on -----Branch-----

That I am aware of the following conditions prescribed under the KMC Act 1976 from time to time for the manufacturing of aerated waters, soft drinks, carbonated soda & soft drinks fruit drinks and squash, fruit jam, ghee, pickle, pappad ,condiments and the like bottled or canned edible oil storing, packing, pressing, cleaning, preparing or manufacturing, blending, processing, storage and sale of tea and I abide to follow the prescribed conditions applicable to the trade carried on by me/us under all Acts and also the following conditions more fully described herein under:

- a. That the building is constructed of masonry;
- b. That every part thereof is constructed of non-inflammable material; and
- c. That suitable accommodation is provided separately for (i) the cleansing of bottles, (ii) the filtration and storage of water, (iii) the charging of bottles, (iv) the storage of all materials connected with such manufacture, and (v) the making and mixing of syrups and proper disposal of all wastes generated
- d. That the floor is of such construction as to be impervious, easily cleansed, smooth and in good repair.
- e. That there is adequate lighting and ventilation in the trade manufacturing /processing premises
- f. Trade premises is be fitted with fly proof mesh or with glass.
- g. That suitable means of drainage upon or in connection with such premises is provided and shall be maintained it in good condition.
- h. That every person shall be provided sufficient and good supply of potable water in such premises and shall cause such premises to be thoroughly cleansed at least twice in every twenty-four hours or more often, if necessary, and shall prevent any accumulation of filth or refuse therein.
- i. That filters, storage, tanks, vessels will be provided for boiling and other appliances of such design, material and capacity as the Medical Officer of Health may by general or special order require for the purification and storage of water and the Trade licensee shall cause to be maintained at all times such storage tanks, boiling vessels and other appliances in a clean and sanitary condition and in good order and repair.
- j. That water which has been filtered and purified to the satisfaction of the Medical Officer of Health shall be used for the manufacturing of aerated waters, soft drinks, carbonated soda & soft drinks fruit drinks and squash, fruit jam and the like bottled or canned edible oil storing, ghee, pickle, pappad ,condiments packing, pressing, cleaning, preparing or manufacturing blending, processing, storage and sale of tea
- k. That for the preparation of aerated waters, soft drinks, carbonated soda & soft drinks fruit drinks and squash, fruit jam, ghee pickle, pappad ,condiments and the like bottled or canned edible oil storing, packing, pressing, cleaning, preparing or manufacturing blending, processing, of tea, vessels of glass or stainless steel or of such other material as approved by the Medical Officer of Health is provided.
- l. That every bottle shall be thoroughly washed and cleansed with a brush or other suitable apparatus, and shall before it is charged cause it to be drained of the water in it by keeping its mouth downwards on a rack provided for the purpose.
- m. That sufficient number of racks of a design approved by the Medical Officer of Health for the draining of washed bottles and for storage of charged bottles shall be provided.
- n. That no flannels, sponges, muslins or other similar materials in the purification or filtration of aerated waters, soft drinks, carbonated soda & soft drinks fruit drinks and squash, fruit jam edible oil, ghee pickle, pappad ,condiments storing blending, processing, of tea be used.
- o. That no manufactured/processed aerated waters, soft drinks, carbonated soda & soft drinks fruit drinks and squash, fruit jam edible oil, ghee pickle, pappad ,condiments blending, processing, storage and sale of tea and the like. in such premises shall be issued without his trade label being affixed thereon.
- p. That every person employed in such business shall be medically examined once every year thereafter. That every such person shall produce a certificate from an authorized Medical Officer of a Corporation Health facility to the effect that he is free from disease or infection of any kind and is fit for employment in such business.

- q. Such certificates shall be granted free of charge by the authorized Medical Officer of a Corporation Health facility and shall be produced by the licensee for inspection as often as may be required by the Health Officer of Inspecting Officer.
- r. That no dog or other pets shall be kept or permitted in any of premises where aerated waters, soft drinks, carbonated soda & soft drinks, fruit drink & squash, fruit jams, edible oil ghee pickle, pappad ,condiments and the like is manufactured, prepared, packed or stored blending, processing, storage and sale of tea.
- s. That it is incumbent at all times to adapt and cause to be maintained in good order and efficient action upon such premises all such means and appliances as the Medical Officer of Health may from time to time, require for the purpose of preventing, any injury to any person employed therein or preventing, abating, or minimizing any nuisance or annoyance to the neighborhood or to the general public.
- t. That an inspection/complaints book shall always be available in the trade premises in which customers or Inspecting Officers may enter their remarks or note their complaints and such book shall be open to inspection by any Inspecting Officer of the Corporation.
- u. Besides these conditions imposed, I will also abide by all other regulations under all other Central and State laws connected in the upkeep of hygiene, safety and public health.

In accordance with these prescribed conditions I/we hereby state that I/we have, to the best of our knowledge and belief, have fulfilled the required conditions for the trade carried on by me/us before applying for this renewal of trade licence. If, upon inspection by the Commissioner or his delegated authority, it is found that I/we have not adhered to these conditions imposed, I/we are aware that the licence issued under the Automatic Trade Licence Approval Scheme, will be revoked. Further I /we HEREBY UNDERTAKE to indemnify/and keep harmless the Corporation from all proceedings in Court and before any other authorities including the competent authority under appropriate Central and State law in force, all express/losses/claims which the Corporation may incur or become liable to pay as a result or in consequence of the renewal of this trade licence.
