CIRCULAR

Subject: Admission of Covid Positive Patients by the hospitals through
online bed management portal CHBMS.

Reference: Govt order No: RD 158 TNR 2020, dated:19.07.2020

As per the order mentioned at reference, it is now mandatory that all the admissions and discharges of COVID patients in the hospitals are to be done through the Covid Hospital Bed Management System (CHBMS) portal provided by the BBMP and SAST for both the COVID-19 patients referred under Government quota of beds and for the private beds administered by the Private Medical Establishments.

In view of the above, any bed allocation done through CHBMS portal by the officers of Bruhat Bengaluru Mahanagara Palike (BBMP) shall be considered as valid and authentic communication to go ahead with the admissions of patients. Hence, physical admission slips or referral letters will neither be issued by the BBMP authorities nor shall be insisted upon by the Hospitals to admit such patients.

However, when any notification on the portal or by e-mail is made by the CHBMS administrator on non-functioning of the portal due to unavoidable technical issues to all the Hospitals and BBMP authorities, the physical referral letter by BBMP may be insisted upon for admission limiting only to such duration of the notification.
